Indemnity Agreement

This agreement applies to anyone who is acting on behalf of Lab Rat Academy. Lab Rat Academy will take all reasonable steps to provide a safe environment for all persons who participate in its activities. On behalf of my child and myself, I hereby waive, release and discharge any and all claims and damages for personal injury, death or property damage that my child may sustain or that may occur as a result of my or my child's participation in these activities.

I understand that:

1. This release is intended to discharge Lab Rat Academy and its employees from and against any and all liability, except for their sole negligence or intentional acts, connected in any way with the participation of my child in these activities;
2. The described activity may be of a hazardous, strenuous, and/or physical nature;
3. Knowing the risk involved, nevertheless I voluntarily request permission for my child to participate in the described activity;
4. I hereby assume any and all risks of injury, death or property damage, and to release and hold harmless Lab Rat Academy and its employees, except for the sole negligence or intentional acts;
5. I will indemnify and hold Lab Rat Academy harmless from any loss, liability, damage, cost or expense, including litigation, which may incur as a result of any injury and/or property damage which my child may sustain while participating in said activities;
6. I will make good any loss or damage or cost Lab Rat Academy may have to pay if any litigation arises on account of any claim made by my child or anyone on my child's behalf;
7. In the event that my child requires medical or surgical treatment while under the supervision of said Lab Rat Academy personnel in connection with the described activity, such supervisor may authorize treatment;
8. I will pay all medical, hospital or other expenses which I or my child may incur as a result of such treatment;

Cancellation Policy

Monterey Bay Cancellation Policy - In the event of being unable to attend a lab, we request that you cancel at least 24 hours before a scheduled lab. You may cancel by phone or online. If you have to cancel your lab, we offer you a credit to your account or a full refund if you cancel before the 24 hours. Charter school funds can be invoiced for a reduced amount if necessary. You may use cancellation credits towards any future labs. However, if you do not cancel prior to the 24 hours, you will lose the payment for that individual lab. Sacramento Area Cancellation Policy - Due to long-term scheduling of these labs, we request that you cancel at least 30 days before a scheduled lab.
