RESOLUTION NO.: SL - 25 - 2025

**TITLE: APPROVAL OF MEMORANDUM OF AGREEMENT (MOA)
WITH THE UNIVERSITY OF NEVADA RENO**

- WHEREAS,** the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 8, 1965, granting certain powers to the Summit Lake Paiute Council; and
- WHEREAS,** the Summit Lake Paiute Council has the responsibility for the general welfare of its tribal membership including tribal natural resources; and
- WHEREAS,** the Summit Lake Paiute Council is the duly constituted governing body within the Summit Lake Paiute Reservation; and
- WHEREAS,** the Summit Lake Paiute Council has been organized to represent, develop, protect, and advance the views, interest, education, resources, and general welfare of the Summit Lake Paiute Tribe membership; and
- WHEREAS,** the Summit Lake Paiute Council supports natural resources management that protects, conserves, and enhances plants and wildlife native to the Summit Lake basin and aboriginal area of the Summit Lake Paiute Tribe; and
- WHEREAS,** the Summit Lake Paiute Council has organized a Natural Resources Department (NRD) to provide technical expertise and services to manage air, water, soil, fish, wildlife, and plants within the Summit Lake Paiute Reservation and off Reservation areas considered the aboriginal homeland of the Summit Lake Paiute Tribe; and
- WHEREAS,** the Summit Lake Paiute Tribe and the University of Nevada Reno (UNR) have had a close, respectful, and productive relationship focused on the \ research and management of Lahontan cutthroat trout and the Summit Lake watershed. The Tribe wishes to continue this work and requests assistance in the following areas to improve the resilience of the Tribe for future generations of members: social, cultural, economic, and ecological; and
- WHEREAS,** the UNR and SLPT seek to establish and maintain a long-term relationship to collaborate, communicate, coordinate, and work cooperatively to advance their mutual interests in enhancing and developing new education and training opportunities, research, and economic development by members of the Tribe; and

NOW THEREFORE BE IT RESOLVED that the Summit Lake Paiute Council hereby authorizes, approves, and consents to entering a Memorandum of Agreement with the University of Nevada Reno for the above purposes; and

BE IT FURTHER RESOLVED that the Summit Lake Paiute Council does not waive, alter, or otherwise diminish its Sovereign Immunity, whether expressed or implied, by virtue of this grant contract for any and all administrative or legal action which may arise directly or indirectly from the same. Furthermore, the Summit Lake Paiute Council hereby authorizes the Tribal Chairwoman to execute any instruments as may be necessary and appropriate to accomplish the above-mentioned actions in the name of and on behalf of the Summit Lake Paiute Tribe.
