Sale of homemade food products must have provided a copy of New York State Permit and a copy of certificate of insurance showing Cohocoton Development Corporation Inc. as additional insured.

All items for sale will be reviewed by the festival committee. Items such as alcoholic beverages, rummage, used clothing, pets, firearms, tasers, hunting or military knives, swords, pea shooters, snappers, tire bats, caps, fireworks, unsafe articles, satanic paraphernalia, or pornography will not be permitted on premises or for sale in exhibition area.

Spacing of vendors is determined by festival committee and vendors are required to use only allocated spaces. The festival committee reserves the right to modify space assignments. Requests for accommodations will be reviewed by the festival committee and will be offered as available. Please include letter of request for any necessary accommodations with your application.

Spaces are leased at \$150.00 each if application is postmarked earlier than **September 10, 2026**. Any applications received after this cutoff will be assessed a \$25.00 late fee. Spaces are leased for both festival days and vendors are required to be available both days. Confirmation email will be sent upon processing your application. If your application is rejected for any reason including space limitations, your check or money order will be returned to you. Once your application is accepted, there will be **NO REFUNDS**.

Spaces are approximately 10' frontage and 10' deep. Electric and water are not provided and generators are prohibited at the festival. Selling directly from a vehicle, in or directly around the park, is strictly prohibited. Vendors are responsible for providing any canopies, flies, tents, or tables they require. Vendors must keep any cables, tie downs, stakes, product, or displays within their reserved space. Load or unload from roadside only. Driving on the grass is not allowed. Vendors are responsible for

removing their own trash from vendor spaces. Leave your space as you found it. Failure to follow these rules may result in bans from future events.

Registration and Set Up Information for Arts and Crafts and Flea Market / Antiques vendors will be in front of the Larrowe House at 15 S Main St, Cohocton. The booth will be open on Friday, October 2nd, from 12:00pm to 6:00pm and on Saturday, October 3rd, from 8:00am to 10:00am. You will receive your space assignment at registration. Vendors may provide their own tents or canopies, but trailers and motorized vehicles are not permitted in the vendor areas. **** Do not set up prior to registration. Violators may have their applications revoked and be asked to leave****

Contest Rules

1. One entry per paid and registered vendor
2. Vendors must provide their own pumpkin
3. Entries will be accepted until 11:00am on Saturday of the festival
4. Do not write your name on the pumpkin, all pumpkins will be given a numbered tag
5. pumpkins will be left outside on display for the duration of the festival. Make sure your decorations can withstand the elements
6. Pumpkins may not be bigger than 1'x1'x1' or weigh more than 35 lbs
7. All entries must be real, vendor decorated pumpkins, no artificial or store-decorated pumpkins
8. Entries must be appropriate and family friendly. We reserve the right to exclude any pumpkin from the contest
9. Decorate your pumpkin before entry. You may use a variety of materials, such as paint, paper, ribbon, glue, glitter, etc. Only decorate the outside of the pumpkin, though. Avoid holes and punctures. **No carved pumpkins allowed**
10. The winner will be chosen by popular public vote through a ballot box on location
11. The winner will be announced at 3:00pm on Sunday of the festival
12. Take a picture of your pumpkin where you leave it. The festival committee may need to move the pumpkins around
13. Any information collected in connection with this contest may be used by the Cohocton Development Corporation Inc. for advertisement or festival promotion
14. Entered pumpkins may be retrieved by participants at 5:00pm on Sunday of the festival or they will be claimed by the Cohocton Development Corporation, Inc.
