

Tuition Policies:

- Tuition is determined by the total number of hours registered per week. Tuition is broken down into 10 equal payments due by the first class of every month.
- Payments that are received after the 10th of the month will receive a monthly, recurring \$15 late fee so long as tuition is past due.
- Tuition is non-refundable. Full season payments are non-refundable. You may be credited in Absolute Dance credit in the event of withdrawal.
- Tuition is not based on class attendance. It is a set price divided into 10 equal payments.
- Students must request a withdrawal form if they wish to stop classes and recurring payments. Withdrawal not received in writing will continue to be charged monthly tuition.
- Costume fees are split into two payments: 1/2 in November and 1/2 in January. Costumes must be paid in full by January. No refunds or credits will be given for costumes.
- Refunds or Credits will not be given for money raised fundraising, tickets purchased, or merchandise purchased.
- NEW THIS YEAR: No cash payments will be accepted. Payments must be made through credit card or through the parent's portal.
