PREAMBLE:

The removal of accumulated snow from the streets of the Village of Cohocton, New York, is in the public interest and welfare of the residents of the Village of Cohocton and all others who may lawfully utilize the Village streets. Accordingly, it is important to provide a means of snow removal by the Village, or its agents and assigns, as quickly and with the least impediments as possible.

SECTION 1.0

No person shall dump, nor plow snow or ice, nor deposit snow or ice on or upon any street or within the limits of the street right-of-way within the Village of Cohocton, New York.

SECTION 1.1

A violation of Section 1.0 shall be punishable by a fine not exceeding \$100 for each such offense.

SECTION 2.0

No motor vehicle, nor any other vehicle, shall be parked on a street, or on the shoulder of a street, which is a New York State highway, within the Village of Cohocton, New York, between the hours of 2:00 a.m. and 6:00 a.m. from November 1 through and including March 31 in each calendar year, during a period of snow removal.

SECTION 2.1

No motor vehicle, nor any other vehicle, shall be parked on a street, or on the shoulder of a street, which is not a New York State highway, within the Village of Cohocton, New York, from November 1 through and including March 31 in each calendar year, during a period of snow removal.

SECTION 2.2

If, in the opinion of the Village Maintenance Supervisor, or his designee, a motor vehicle or other vehicle is parked on a Village street, or on the shoulder of a Village street, within the Village of Cohocton, New York in violation of Sections 2.0 and 2.1, and the presence of such vehicle on the Village street, or the shoulder of the Village street, impedes the proper snow removal from said street, or shoulder of said street, then the Village Maintenance Supervisor, or his designee, is authorized to cause the removal of said vehicle to a designated place to be held. Notice of the removal of said vehicle shall be given by the Village Maintenance Supervisor, within twenty four (24) hours of said removal, to the registered owner of said vehicle and the Village Maintenance Supervisor shall further advise the registered owner where said vehicle is held and that the vehicle may be claimed. The registered owner shall be responsible to pay all reasonable towing, removal and storage charges of said vehicle and said payment of said charges shall be made prior to the return of said vehicle to the registered owner.

SECTION 2.3

A violation of Sections 2.0 and 2.1 herein shall be deemed committed by the registered owner of said motor vehicle or other vehicle.

SECTION 2.4

No liability shall attach to the Village of Cohocton, its Village Maintenance Supervisor, or his designee, with respect to the removal of a motor vehicle or other such vehicle as provided in Section 2.2.

SECTION 2.5

The words "street", "motor vehicle" and "vehicle" used in Sections 2.0 and 2.1 shall be given the same meanings as such terms are given in the Vehicle and Traffic Law of the State of New York.

SECTION 2.6

A violation of Sections 2.0 and 2.1 shall be punishable by a fine not exceeding \$100 for each such offense.

SECTION 3.0

The Village of Cohocton, New York, shall not be responsible and shall be held harmless for any damage to any mailbox located within the right-of-way of any Village street caused by snow plowing or snow or ice removal by the Village of Cohocton, New York.

SECTION 4.0

This Local Law shall take effect immediately.
