ORDINANCE NO. 2012- 8

AN ORDINANCE AMENDING THE TOWN CODE BY RESTRICTING TRUCK PARKING

WHEREAS, the Town council of the Town of Cloverdale , Indiana (the "Town Council") has determined that truck and camper parking should be limited for safety reasons.

BE IT ENACTED

That the town code should be modified by adding the following provisions.

Section § 8.099 NO TRUCK OR CAMPER PARKING ZONES

- (A) The location described in Parking Schedule V below designated no truck or camper parking zones.
- (B) When appropriate signs conforming to the requirements of this Traffic Code are erected, no person shall park a truck or camper on the side of the street indicated by the schedule.



PARKING SCHEDULE V

NO TRUCK OR CAMPER PARKING ZONES

- 1. 5 ~~North~~ ^{South} Main Street as marked.

Section § 8.999 PENALTY

(A) Any person who shall violate any of the provisions of this chapter and any person, who aids, abets, or assists therein shall, upon conviction thereof, be subject to a fine of not less than \$100.00 (One Hundred Dollars and No Cents) and not exceeding \$2,500.00, plus additional penalties to include responsible attorney fees and court costs incurred by the town for collection of the account.

This ordinance supersedes and replaces any rule regulation or ordinance that conflicts with its provisions.

This ordinance is effective as of the date of passage and publication as required by law.
