1. Call to order; Roll call

5. Receive Assessment Roll and Sworn Clerk's Statement

The assessor's affidavit certifying the contents of the 2025 roll was completed by the assessor and the clerk. Assessor Jake Baumbach stated that all changes have been incorporated into the roll and that there were no open book changes.

6. Objection Forms
