Contract Cancellation

The Producer has the right to cancel contract to exhibitor at any time during The Event and request the Participant to leave if at any time they are conducting business that is not in the good for the festival and reputation of the Producer according to the rules and conditions. No refunds if exhibitor is asked to leave for violations in terms and conditions.

Any Participant that cancels before July 1st 2018 will receive all but \$25 of any deposits. No refunds are given after September 1st, 2018

Set-up & Tear-down

Times on front of contract. **NO EARLY TEAR-DOWN**

Show Hours & Operations

The Participant will be responsible for the appearance of its space and to take all trash to dumpster. Gray water and grease will be dumped in the assigned containers. Do not place trash in the containers set out for the public.

Tar paper must be placed on the blacktop where cooking will take place. This is not needed if you are on grass.

Exhibitors must man their booth space during show hours.

Merchandise Sales

No alcohol, pornography, offensive material, nudity, guns or tobacco may be sold or displayed.

Recorded Music

Exhibitor must not play any recorded device at a volume that disturbs their neighbors, or while live music plays.

Tents

All pop-up tents must be secured with weights. Recommended 24# per leg. No driving of stakes into blacktop.

Weather
