RESOLUTION NO: SL-22-2017

TITLE: DISENROLLMENT OF THALIA A. DICK

WHEREAS, the Summit Lake Paiute Tribe is organized pursuant to Section 16 of Indian Reorganization Act of June 18, 1934 (48 Stat. 984) as amended, with the Articles of Association, and approved by the Secretary of the Interior on January 08, 1965, granting certain powers of the Summit Lake Paiute Council (see Article II, Section 1) to include establishing a membership roll and enacting regulations governing the loss of membership (see Section 1 (j)), and to take such actions as are necessary to carry into effect any of the foregoing powers and duties (see Section 1 (k)); and

WHEREAS, the Articles of Association of the Summit Lake Paiute Tribe, Nevada (hereinafter) Articles of Association), Article III, Section 1 prescribes eligibility requirements to be a member of the Summit Lake Paiute Tribe, and Section 1(c) states descendants of the Summit Lake Paiute Tribe must possess at least one-fourth degree Paiute Indian blood to be recognized as a tribal members; and

WHEREAS, the Summit Lake Paiute Tribe Enrollment Procedures Ordinance enacted by Resolution SL-17-89 and amended by Resolution SL-29-99 prescribes procedures to act on enrollment matters; and

WHEREAS, disenrollment is addressed in Article V of the Summit Lake Paiute Tribe Enrollment Procedures Ordinance, wherein Section 1 (a) states the Summit Lake Paiute Council shall disenroll any person who obtained membership rights by fraud, deceit, or misrepresentation; and

NOW THEREFORE BE IT RESOLVED, on October 21, 2017, the Summit Lake Paiute Council passed Resolution SL-22-2017 to disenroll Thalia A Dick because (a) the person obtained membership rights by fraud, deceit or misrepresentation and appears on the Census of the Summit Lake Reservation as of January 1, 1940, except that those persons whose names are preceded by the notation "N.E." shall not be eligible for membership. Written notice was given by certified mail to meet on Monday, October 16, 2017 and Ms. Thalia A. Dick was present at the hearing.

BE IT FURTHER RESOLVED that Summit Lake Paiute Council must immediately remove Thalia A. Dick from the Summit Lake Paiute Council and the membership roll of the Summit Lake Paiute Tribe as she does not qualify for membership.


BE IT FINALLY RESOLVED, that this decision of the Summit Lake Paiute Council is final and shall not be appealed.
