

Town of Stratton Selectmen's Meeting

June 11, 2018

Present: Selectmen: Chair, Al Dupell, Larry Bills, Chris Liller, Greg Marcucci, and Kevin Robinson; and Clerk – Kent Young.

Al Dupell called the meeting to order at 7:30pm. Orders were reviewed and signed.

Agenda Modifications: No modifications were made.

Road Crew Issues: Health Insurance: Ralph Staib will be switching over to be covered by his wife's health and dental insurance plans effective July 1, 2018. The Selectmen agreed to pay the out-of-pocket expense her employer charges for the coverage, which is \$270.49 per month for health insurance and \$53.97 per month for dental insurance. The Selectmen also agree to have Mr. Staib's health insurance through the Town's policy cancelled effective July 1, 2018 as part of this transition. Chris Liller so moved. Kevin Robinson seconded – all concurred. **Culverts:** Renaud Bros. Construction was contacted for assessing the installation of the failing culvert on the north side of Kidder Brook. Al Dupell asked that the Road Crew contact him so that he can be present during their visit. **Access Permit:** The Selectmen reviewed an Access Permit application submitted by the Southworths for their lot on the Stratton-Arlington Rd.. The proposed placement, as submitted with the application was acceptable to the board. The permit was conditioned on coordinating with the Road Crew regarding the installation of a culvert, as necessary. All the Selectmen signed to approve the application. **Signage:** The Selectmen reviewed a letter submitted by Lorraine Weeks-Newell regarding the road sign in front of her house. The sign vibrates when the wind blows and makes a lot of noise. Chris Liller said that he will look into installing a double-posted sign to eliminate the problem. **Hazardous Tree:** The Clerk said that it was pointed out to him that there is a dead / dying tree leaning out toward the schoolhouse that should be dealt with before it falls onto the building. Chris Liller acknowledged the problem.

Town Office Alarm System: Kent Young said that George Wilson has completed the installation of the alarm systems in the Town Office. He will have the Fire Dept. install the key and the code in the Knox Box.

Town Hall: Furnaces: The new furnaces have not yet been delivered. The road crew verified that the crawlspace drain is attached to the perimeter drains, but the outlet to daylight has not yet been found. The Road Crew will continue to search for the outlet, and will clear it to allow proper drainage. **Usage:** The Selectmen agreed to allow the Lillers to use the Town Hall on July 29.

Minutes: Greg Marcucci moved to approve the Selectmen's Minutes of May 29, 2018. Chris Liller seconded. The minutes were approved.

Adjourn: Greg Marcucci motioned to adjourn at 7:50p.m.. Chris Liller seconded. All were in favor and the meeting adjourned.
