#### **Judicial Goals**

Briefly describe what you hope to accomplish as a judge.

Serve the people well regardless of my divisional assignment. Serving them well includes respecting the dignity of each litigant, lawyer, victim, interested family member, witness, clerk, court reporter, courtroom deputy, and judicial assistant; includes applying the legal process to all issues presented with dedication to the law rather than preference to the outcome; includes case management that

enables citizens to have their voices heard and their issues resolved as expeditiously as possible while respecting everyone's Constitutional right of due process; includes respecting the time and attention of citizens performing their invaluable jury service; includes protecting the downtrodden and disenfranchised with the same vigor and respect as that afforded the well-heeled; and separate my work life from my family life.

#### Briefly describe the greatest strengths you bring to the judicial role.

Experience. It is important that judges have a passion for the law, that they know and understand both the substantive areas assigned to them and the rules of evidence and procedure. However, it is imperative that judges have an even deeper knowledge and understanding of people and their concerns, foibles, needs and desires, and their sense of justice. Any lawyer can find the law simply by pulling out a smart phone, but that is not enough. A judge in civil courts may have to decide whether to shut down a business or take away a family home. A judge in family courts may have to take a parent's children away. A judge in criminal courts may have to take somebody's freedom away or even, tragically, someone's life. Those are not legal decisions but life decisions. Discerning what action to take requires a reservoir of wisdom that cannot be found in law books. A judicial candidate seeking the bench too early may not know the depth of the issues inherent in the position, may lack the seasoning to discern artifice from truth, and may be unprepared for the long line of citizens at the door of the courthouse seeking truth and justice in a circumstance that they and their lawyers have been struggling with for years without finding a fair resolution. When they place it all – their homes and business, their children, their freedom and lives – in the judge's hands, it is too late for that judge to realize that some things cannot be taught; they must be experienced. To learn the most valuable lessons in life that will enrich a judge's skill for discernment, that person must first go through his/her own journey. The bench is no place to learn as you go.

#### Briefly describe your view/opinion of proper judicial temperament.

The biggest surprise to me when I left the practice of law upon being elected Circuit Judge was the mental, emotional and physical demands the position places on a jurist. As a lawyer, there are moments of high stress when you have to be "on your game" but those are surrounded with periods of calm when you can regroup and relax. I recognized quickly that a judge has no down time, that the judge must be "on your game" at all times. I learned the hard way that failure to recognize how important it is for a judge to step back and take time to rejuvenate, especially after a high-stress matter, is to dangerously underestimate the toll the position takes on a person. The judge has to bring fresh, positive energy to each matter, no matter how busy the day, or even the month, is. The best practice to attain proper judicial temperament – patiently treating every person in the courthouse with dignity and respect – is for a judge to respect his/her own need to find inner calm, so each day, each case, each lawyer/client, each person associated with the work of the courthouse, is presented with a judge of pleasant and professional temperament.

Have you ever been disciplined by a state or local Bar? Yes If so, explain briefly.

As a judge, I agreed to receive a reprimand for not maintaining the highest standard of conduct and for not being courteous to an attorney when I disciplined his behavior in a jury trial without first excusing the jury from the courtroom, which may have adversely affected the client's right to a fair trial (ultimately, the client won at trial) and then for not immediately removing myself from the case when asked to do so by the attorney. Prior to the reprimand, I apologized to the attorney in writing for my error, an error I have not repeated and will not repeat. While the vast majority of American judges do not have to deal with the possibility of imposing the death penalty in any particular case, I presided over four death penalty trials just in my first term alone. I failed to recognize the toll that level of professional stress took on me and how it affected my judicial temperament. At my request, I had my assignment changed out of Criminal Division temporarily in the fall of 2019, to step away from jury work and high-profile criminal trials. My time away the high-profile and death penalty trials has been personally and professionally beneficial and fruitful.

## Have you ever been arrested or convicted of a crime? <u>No</u> If so, explain briefly. SUMMARY: Briefly explain why voters should support your candidacy.

A courthouse can be an environment overcast with human distress. Pain and suffering – yesterday's, today's and/or tomorrow's – walk the halls of each Broward courthouse. Discouragement too often overcomes citizens directly/indirectly affected by the decisions handed down in each courtroom. The legal citizenry comes before each judge yearning for consistent fairness, deep justice and hard decisions tempered by mercy and empathy but, understandably, each citizen also comes with a subjective agenda. Judges cannot solve every problem in society, or even reach decisions which satisfy everyone, but we can bring hope to those who stand before us. By honoring my duty to apply the law with no attempt to rewrite it to suit my preferences, by working just as hard as any man earning his living with the strength of his arms and the breadth of his back, by listening to citizens with the same earnestness as any parent to their child's cares and concerns, I will fairly and compassionately serve every person within this jurisdiction as I have during my first term. I will continue to work as hard as ever to remain efficient and productive, I will make sure no litigant is denied either access to court or the right of due process in his/her search for truth and justice, and I will give no interested citizen cause to shake her head in disappointment that the process I employ is either arbitrary or unbalanced. By doing so, I will honor the trust placed in, and responsibility placed upon, Judge Dennis Bailey.

Briefly describe what you hope to accomplish as a judge--I will strive to bring honor, fairness, compassion, and justice to the position I seek, and uphold the integrity of the bench. I understand that it is a privilege to be a judge, and I will be thankful for that privilege every single day, every single hour, and every single minute should I be given the favor of being elected by the people of this county. The people of Broward County have had some unfortunately negative experiences with a few members of the bench in recent years. It would be my goal to make the citizens of Broward proud to have me as their Broward County Circuit Court Judge and restore in some small part a feeling of pride in the Broward judiciary. I have developed a work ethic after years of dedicated service. As a judge I know

that I must work hard, even harder than the litigants who come before me, as I will be the one tasked with making decisions that will affect many people and many lives. That means long hours both before the litigants and court personnel show up, and also well after they've left for the evening. It means being fully prepared to listen and rule, and to rule consistently, not letting favoritism or irritation with a litigant or concept affect my rulings.

Briefly describe the greatest strengths you bring to the judicial role—I bring experience and patience. There is no substitute for experience, both in the law and in life. I've spent the last thirty-nine years learning the law, learning how to listen, and learning how to look at things from a 360-degree perspective. I understand the value of hard work and putting in the effort necessary to achieve one's goals. I was not a child of privilege, but I was lucky to grow up in an unconditionally loving home. I was taught perseverence, to work hard for what you wanted, how to cope with loss, the love of country, and fealty to the law. I worked two jobs to put myself through school after the untimely death of my father when I was a teenager. My perspective has not only been shaped by the positive things that have occurred over the years, but also by the tragedies and the negative events that I've experienced.

Briefly describe your view/opinion of proper judicial temperament—Proper judicial temperament can be summed up in one word: respect. How a judge behaves in the courtroom has a ripple effect on not only the way he or she is perceived, but how the public perceives the court system. A judge who does not respect the time of others, or does not exercise discretion wisely, thoughtfully, or soberly, gives the impression that justice is decided on a whim. People want to believe they are being heard; a judge who does not listen does a disservice to the litigants and the system. Not everyone will be happy with the judge's ruling, but at least they will feel they have had a voice and have been heard.

#### SUMMARY: Briefly explain why voters should support your candidacy

I will always be mindful that to be chosen a judge is a privilege and an honor bestowed by the people and not a personal right or possession. I will be sitting in a courtroom belonging to the people, at the will of the people, because of the grace of the people. That honor will never be lost on me. I have wanted to be a judge since the day I took the oath of the Florida Bar. However, I knew that to be the best judge I could I would need to hone my craft and my skill so that I could effectively serve the people. So, I waited until I thought I had the experience and maturity to be the most effective judge and servant. In 2011, I began an unsuccessful journey to appointment to the bench by the governor, although I had been warmly received by the Seventeenth Circuit Judicial Nominating Commission; they favored me with a nomination many, many times. I decided that my road to the bench would have to follow a different path and I decided to let the people decide; hence, this run for judicial office. My reason for wanting to be a judge, and for never giving up the quest is simple: I am a public servant. I was destined to serve the public and give back as thanks for what this community, this state, and this country gave to me and to family members who came before me. Money has never guided me in anything I did; it's nice to have, but I've never chased the dream of being wealthy. The feeling one gets when they've served the public cannot be defined or bought; it can only be felt. Some people get satisfaction from possessions, others do not. I'm in the latter category.

It really goes back to my grandparents, particularly my maternal grandmother, whose passing 47 years ago later this month still brings me pain. My maternal grandparents did not have an easy road coming to the promised land called America. My then-sixteen-year-old grandfather was shot fleeing from the Russian army which was forcing his service to a government that wanted our people annihilated; he proudly carried those shotgun pellets in his body as a symbol of his freedom until he died. My maternal grandmother, the oldest of ten children, was put on a boat at the age of fourteen to cross the ocean alone to a life her parents could not give her. I cannot imagine the courage it took for them to do this all by themselves as mere children. Yet they constantly taught us the greatness of service to this country, because the United States opened its arms to them and welcomed them in, allowing them to work and become valuable members and citizens of our society. The law which made this country a symbol of liberty for all was something that was so valuable that they were willing to leave everything and everyone behind to live under the umbrella of freedom. As a result, I was always taught country/community first, and that's what has carried over. I want to continue to serve my community as a judge, taking my public service to the next level.

Briefly describe what you hope to accomplish as a judge.

- 1. **Improve the public understanding of the courts.** We should work to establish a website that contains a "one stop" shop of information. This information would contain the credentials of the jurists, their ruling records, judgements, peer reviews, potential conflict of interests and qualifications.
- 2. **Help educate and increase access to courts.** The rising costs of litigation is making it more difficult for citizens to bring issues before the court. This includes lengthy discovery obligations and stagnant movement throughout our court system.
- 3. **Increase judicial efficiency with a 21-century mindset.** I would advocate that we use zoom hearings and conference calls more frequently to expedite hearing access and reduce high volume court dockets. This will be a benefit not only to the justice system but also reduce cost across the board for the judicial circuit.

Briefly describe the greatest strengths you bring to the judicial role. Serving in the United States Marine Corps taught me honor, courage, and commitment. I bring to the bench patience, open-mindedness, courtesy, tact, punctuality, firmness, understanding, compassion, humility, and common sense. My life experiences are my greatest strengths. One, as a Juvenile, I was arrested nearly eighteen years ago and understand the consequences of bad decisions. I understand that despite "humble beginnings", growing up without my biological father, and being raised in a disenfranchised community we all must be responsible for our actions. However, when appropriate we deserve a second chance. I understand the benefit of accepting responsibility for your actions and working hard to improve yourself and everyone around you. Two, I understand the importance of our constitution and the sacrifices men and woman have made to protect and defend its core principles. Third, I bring a wealth of life experience, humility, and wisdom to the judicial role. The ability to apply the law

I have already presided over numerous Zoom hearings and am working not only with the Broward County Court system, but also as a Judicial Advisor in the national Civil Jury Project, to envision and establish remote jury trials over Zoom or similar platforms.

In the Court's ruling they issued a reprimand and stated that although I had violated the canons that I had a reputation as a smart and conscientious judge, that I would not repeat the action as it was a one time incident. Since that time I have served Broward County with no further ethical violations. I regretted my actions that day and apologized at the time.
