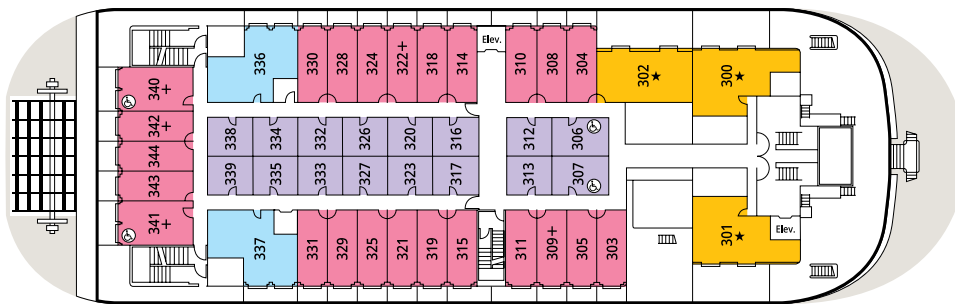

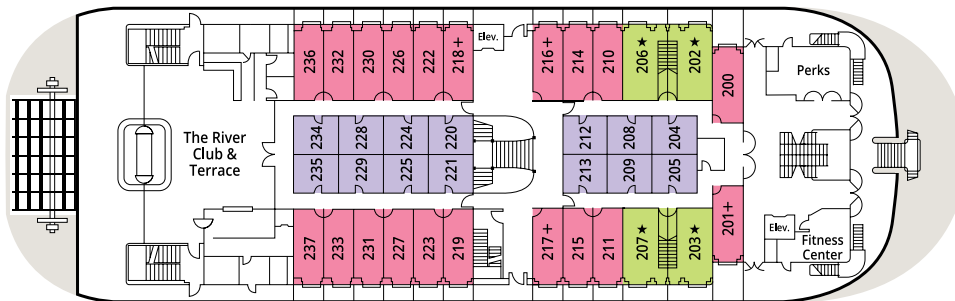

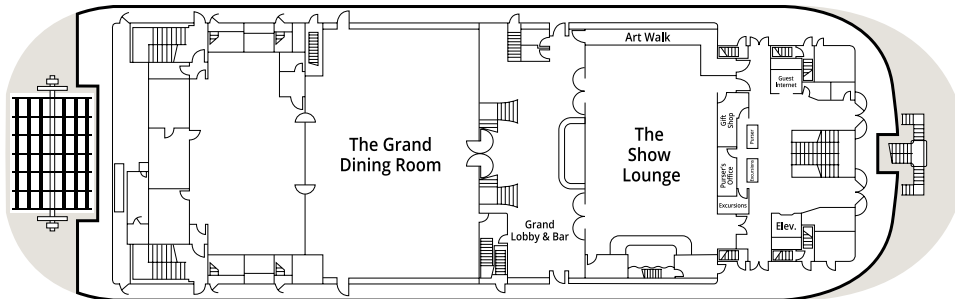
DECK 4 – SUN DECK

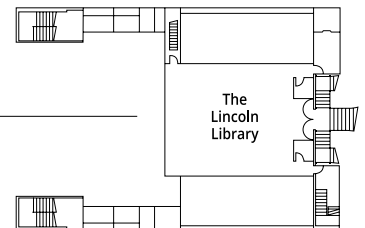
