

Ordinance Number 648.

An ordinance appropriating certain Money's.

Be it ordained by the Mayor and commissioners of the city of Garnett, Kansas,

Section One:- that the sum of *Two Hundred and Thirty Six and 07/100* Dollars be and the same is hereby appropriated out of the General fund in the hands of the City treasurer to pay the Bills allowed said fund at a regular meeting of said Board held on the 3d day of January 1916. a list of which may be found on page 236 of the journal of the proceedings of the Board on said date.

Section Two:- that the sum of *Three Hundred and Forty Two and 13/100* Dollars be and the same is hereby appropriated out of the water works Fund in the hands of the city Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 3d day of January 1916, a list of which may be found on page 256 of the journal of the proceedings of the Board on said date.

Section Three:- that the sum of *Two Hundred and Forty Three and 47/100* Dollars be and the same is hereby appropriated out of the Street fund in the hands of the City Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 3d day of January 1916. a list of which may be found on page 255 of the journal of the proceedings of the Board on said date.

Section Four:- that the sum of *Four Hundred and Twenty One and 45/100* Dollars be and the same is hereby appropriated out of the Electric Light Fund in the hands of the City Treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 3d day of January 1916. a list of which may be found on page 256 of the journal of the proceedings of the Board on said date.

Section Five:- that the sum of *Sixty Two and 43/100* Dollars be and the same is hereby appropriated out of the Water works improvement Bond fund 1915. in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 3d day of January 1916. a list of which may be found on page 256 of the journal of the proceedings of the Board on said date.

Section Six:- that the sum of *One and no/100* Dollars be and the same is hereby appropriated out of the fund of Sewer District number (2) in the hands of the city treasurer to pay the Bills allowed against said fund at a regular meeting of said Board held on the 3d day of January 1916, a list of which may be found on page 254 of the journal of the proceedings of the Board on said date.

Section Seven:- that the mayor and city clerk be and are hereby authorized and instructed to draw warrants on the city treasurer to pay the Bills allowed in the forgoing sections of this ordinance.

Section Eight:- that this ordinance shall take effect and be in force from and after its passage by the Board of Commissioners and its approval by the Mayor.
