Quarterly Investment Report – September 30, 2018

Treasurer Getty presented the Investment Report for the Quarter ending September 30, 2018. Over the past quarter, the TTO benchmark Bank of America Merrill Lynch Treasury & Agency Index rate of return diminished 8.23%. Concurrently, the TTO portfolio annualized rate of return on investments only decreased 6.33%. The TTO had a 58% increase on the rate of return to the member districts for 2018 First Quarter compared to prior year.

Treasurer Getty reported the following TTO Interest Return comparison to the Member Districts for the First Quarter:

- Q1-2017 \$ 675,000
- Q1-2018 \$ 1,065,000

Establishment of Employee 401(a) and 457(b) Retirement Plans

President Thiessen requested the Retirement Plan discussion be held at the next Trustee meeting on January 7, 2019 when all Trustees are present.

School District Resolutions

Treasurer Getty presented three school district resolutions from LaGrange Elementary School District 102, Lyons Elementary School District 103, and LaGrange Elementary School District 105 which states: "the Board continues to believe that it can provide the same services as the TTO with greater efficiency and less cost" and authorized the Board President to "collect information and develop options for modifying the relationship with the TTO". Discussion was held on how the resolutions can positively build a stronger relationship between the TTO and member districts.

OLD BUSINESS

West 40

Treasurer Getty discussed the fund balance of West 40 Educational Services with the Board of Trustees. West 40 Educational Services current October 2018 ending fund balance is \$624,145.16. West 40 Educational Service is forecasted to increase its June 2019 quarterly payment to \$1.2MM. Treasurer Getty also updated the Trustees on the "Regional Office of Education Funding" (105 ILCS 5/18-8.15) Sec. 18-8-15. Evidence-based funding for student success for the 2017-2018 and subsequent school years terms.
