• **Covering Boat:** Shrinkwrap Zipper access door Moisture Control (Dehumid) bags in cabin

NOTE: FHYW is not responsible for wind/weather damage to shrink wrap/cover or mildew that may occur during storage. Some boats will require removal of summer canvas/bimini top. A fee will be charged for removal and storage.

OTHER WORK OR SERVICE DESIRED (Fiberglass, woodwork, electronics, mast and rigging, etc.) Please List:

Fair Haven Yacht Works requires a signed winter storage contract with payment to reserve a haul out date. No work will be done on your boat without a signed authorization work order. Decommissioning charges are due on completion of service. No vessel is launched without payment in full of all outstanding balances. Accruing charges shall constitute a valid lien against the vessel until all charges are paid in full. All boats, electronics, and personal gear (if remaining onboard) are stored at owner's risk. FHYW is not responsible for any loss of property due to fire, theft, vandalism, wind, snow, ice, severe weather, or any other casualty (including personal injury to owner or guests while the boat is in storage). All owners are required to maintain their own insurance to protect against such loss. Your signature above releases and forever discharges FHYW from all actions or claims relating to or caused by such losses or damages while in winter storage.

NO OUTSIDE CONTRACTORS WILL BE PERMITTED TO WORK ON BOAT WITHOUT PRIOR APPROVAL AND PROOF OF INSURANCE.
Owners are not permitted to work on boats (other than cosmetic). This includes mechanical/electrical/engine repairs and bottom painting.

My signature authorizes the completion of work (along with the necessary materials) and grants employees or subcontractors of FHYW permission to operate the vessel/engine for that purpose. My signature acknowledges reading and understanding the costs of these services (without an estimate) and of the terms stated above.
