# **Commissioners Report (Sue)**

#### **UPDATE/REMINDER -**

Safe Weather Conditions – Sue reviewed the safety protocol for adverse weather, specifically thunder and lightning storms, in several areas.

Policy on players with casts - A discussion regarding the use of a cast during practices and games was discussed in length. Leagues in District 8 will not allow hard casts at practice or games. Sue will research the subject further and report at next District meeting.

USYS Change to State Cup National Championship (Competitive) – Sue let the leagues know the changes to the new USYS State Cup National Championship series and encouraged all leagues/clubs that have competitive teams to sign up for Cal North Cups. Winners will advance directly to the National State Cup.

USYS Of The Year Awards 2025 – Sue announced the new program for Awards of the Year and will give out more information when she receives it.

Sue again reminded the leagues/clubs about the change in registration for the 2026-2027 seasonal year being changed to school term (August 1 – July 31) vs the birthyear like it has been for several years. She advised the leagues and clubs to advertise and educate the parents starting now so they are all aware of the changes.
