**PENTWATER SPORTFISHING ASSOCIATION BOARD MEETING – May 15, 2021**

PENTWATER VILLAGE PARK PLACE

Directors Present: Rob Bannink, Dean Jessup, Bruce Koorndyk (past president), Brad Smith, Patsy Gettings, David Vanderveen. Absent: Dan Gettings, Steve Sauser. Guest: David Rouse.

Meeting called to order at 3:12 p.m. by President Dean Jessup.

1. **Treasurer's Report:** Patsy G. handed out the report and reviewed it. PSA continues to maintain a strong checkbook balance. Brad S. moved, seconded by Rob B., to accept the Treasurer's Report as presented. Motion carried unanimously.
2. **The Meeting Minutes** from the September 19, 2020 Board Meeting were reviewed with no questions or revisions. Brad S. moved to approve the minutes as submitted, seconded by Rob B. Motion carried unanimously.
3. **Dean J. reviewed the 2021 PSA Schedule of Events.** The water safety day on June 19 has been confirmed. The Boater Safety classes have not yet been confirmed. All other events will take place as scheduled.
4. **2021 Board Seats:** We anticipate one or two open board seats by the end of 2021. Board members are asked to consider possible candidates to join the board.
5. **Clothing Update:** Dean J. announced that current inventory is in good shape, and Dan Gettings will have clothing ready for sale at for the Memorial Weekend Derby.
6. Most of the **channel lights** have been installed. Dean J. is working on one additional light that should be installed soon.
7. Bruce K. is following up on the **installation of No Wake buoys and lights.**
8. Lyn Snider has agreed to do the **PSA newsletter** again in 2021. The board appreciates Lyn's continued efforts on the newsletter.
9. Dean J. announced that signs for the **PSA Derby** have been placed around Pentwater.
10. The **Village Launch ramp light has been installed.** The ramp itself is listing. Dean J. has spoken with Chris Brown about this, and the Village has a plan to fix the ramp.
11. Dean J. shared information from the **MSU Salmon Stomach Study.** A freezer will be placed at the Village Marina, and supplies will be available at the freezer. PSA members are encouraged to participate in the study.
12. Dean J. gave a brief update on the **Consent Decree negotiations.** The board discussed making an additional donation to the Coalition to Protect Michigan Resources (CPMR) which represents sportsmen in the negotiations. Brad S. made a motion to donate an additional \$250 to the CPMR, seconded by Bruce K. Motion carried unanimously.
13. Dean J. spoke with Chris Brown regarding the **Village Marina fish cleaning station.** Repairs are scheduled for the week of 5/17/21, and the station should be open after that.
14. Bruce K. reported on memberships. We have 26 paid members to date for 2021.
15. The board discussed plans for the Memorial Weekend Derby.
  - a. Raffle tickets sales are underway. Tickets are available from all PSA board members.
  - b. Dean J. reported on registration plans. Forms will be available at Charlies Marina prior to the Derby, and at the Friday evening registrations 4:00–8:00pm on May 28. Online registration is available until 8:00pm on May 28.
  - c. Brad S. will schedule weigh-in teams for the Derby.
  - d. Dean J. ordered trophies for all prize categories.
  - e. A PSA member donated \$300 for a daily big fish prize. The board discussed using a "big fish bonus pool" in which the three biggest fish each day will be entered into a drawing and the winner of the drawing will receive the \$100 prize.
  - f. Bruce K. made a motion to give a \$100 gift card to Rick Miotke who donated the fish carving for the Derby grand prize. Seconded by Brad S. Motion carried unanimously.
  - g. The board reviewed prize donations to date. We have a good collection of cash, gift certificates and products for the Derby.
  - h. Rob B. made a motion to eliminate the Charter Boat Challenge from this year's Derby. Seconded by Brad S. Motion carried unanimously.
16. Rob B. moved to adjourn the meeting, seconded by Brad S. Motion carried unanimously and the meeting was adjourned at 4:19 pm.
