<u>Marijuana Licensing</u> - for commercial establishment centers in our township, Ordinance with county pending that would stop the establishments. Board decided to table the discussion until next month after obtaining more information. Motion was made by Roof seconded by Kindel to table.

<u>Election Report</u> - there was 1074 voters. All things went well with the new machines; the only thing that will be done differently is that there will be a table set up with dividers so that more can vote at one time.
