# RESOLUTION OF THE TOWN OF DIX TOWN BOARD

WHEREAS, the Town of Dix is the owner of certain real property and improvements located at 304 7th Street, Watkins Glen, New York (the "Property"); and

WHEREAS, the Town of Dix currently uses the Property as the Town hall and certain other administrative functions; and

WHEREAS, the Town of Dix is in the process of transferring these functions to another location, and as such the Property will, upon the completion of this process, become obsolete and unneeded by the Town of Dix; and

WHEREAS, the Town of Dix has entered into a contract to sell the Property dated September 13, 2022 (the "Contract"), which Contract is expressly contingent upon the approval of the sale of the Property by the Town of Dix Town Board; and

WHEREAS, the Town of Dix Town Board has reviewed the Contract with the real estate agent engaged as the listing agent for the Property and with the attorney for the Town, and has concluded that the sale price provided for in the Contract is the best price reasonably available for the Property, and that the other terms of the Contract are the most beneficial terms available in the public interest; and

WHEREAS, the sale of the Property by the Town of Dix is subject to review by the Town Board pursuant to the New York State Environmental Quality Review Law, Article 8 of the Environmental Conservation Law and the regulations adopted pursuant thereto at 6 N.Y.C.R.R. Part 617, as amended (collectively referred to as "SEQRA"), and the Town Board has undertaken and completed such review.

NOW, THEREFORE, be it resolved by the Town of Dix Town Board as follows:

- 1. The sale of the Property pursuant to the terms of the Contract is approved, subject to permissive referendum pursuant to Town Law section 64(2).
- 2. The Town Supervisor is authorized and directed to execute and deliver such documents and agreements on behalf of the Town as may be necessary or appropriate to consummate the sale of the Property pursuant to the Contract, and all prior actions of the Town Supervisor in furtherance of the sale of the Property pursuant to the Contract are ratified and approved.
- 3. The Town Board of the Town of Dix finds that the sale of the Property will have no significant adverse environmental impact.
