## TOURNAMENT RULES

1. The End of Season Scholarship Singles Tournament is open to all current USBC Youth Sanctioned Bowlers in a certified youth league within the Appomattox River USBC with a minimum of 21 games within the league.
2. This tournament shall be a Singles competition. All bowlers will bowl a series of 3 games.
3. Bowlers may enter more than once (bowling one squad per day) with the bowler's highest 3 game series being used for final position standings. There is a limited amount of space on each squad. An additional squad per day may be added to help accommodate all bowlers. Bowlers who participate both days, will have scores combined for a 6 games total score eligible for additional scholarships.
4. Averages as of Jan.1, 2020, based on a minimum of 21 games in their league, is needed to participate in this tournament. If a youth bowled in multiple leagues, the highest average will be used. All averages must be a USBC certified league average within (USBC Rule 319A). Coaches must verify average on entry form. An average sheet is to be sent to Tournament Manager for average verification. No late entries will be accepted after the postmark due date. (See top of entry form)
5. Handicaps shall be based on $100 \%$ of the difference between the individual average and 200 . The bowlers will be divided into FOUR divisions as follows: DIVISION 1: Average 75 \& Under, DIVISION 2: 76 to 120, DIVISION 3: 121 to 160, DIVISION 4: 161 and up. An optional All Events Scratch for each Division using scratch scores from two day completion will be offered. Divisions subject to being adjusted, based upon the number of entries.
6. WALK-INS WILL NOT BE PERMITTED. Late bowlers will receive a zero for frames missed.
7. Full entry fees must accompany entry form. Bank return checks will be charged $\$ 25$.
8. Conduct derogatory to the best interest of youth bowling while competing in tournament play may result in possible suspension.

9. Any appeal or protest regarding a decision of the score, tournament official, must be made in writing to the Appomattox River USBC Tournament Manager or Chairman, ARUSBC Youth Committee, no later than 72 hours after posting the final standings on the ARUSBC website (www.arusbcbowling.com). If no written protest is received prior to the 72 hour period, the decision will stand. See USBC Rule 329.
I0. Scholarships will be awarded in all 3 game, 6 game divisions \& All-Events Scratch (Minimum of 5 per division, if not refund will be issued). All Scratch funds will be returned $100 \%$. At a minimum, one scholarship will be given out in a division. For every 5 entries received in a division, one scholarship will be awarded. All scholarships will be issued though USBC SMART program. ARUSBC Smart Account\# 8620.
II. Confirmation of entry will be sent to each bowling center's coach or alternate designee before the tournament dates.
12. All other decisions will be made by the ARUSBC Youth Committee and Tournament Manager.
13. HATS, HEADPHONES, EAR BUDS, IPODS, MP3 type devices, and Inappropriate T-Shirts are NOT ALLOWED. All bowlers must wear suitable attire.
