

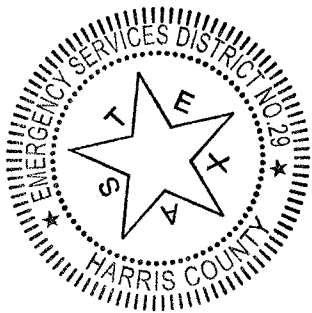
MEETING NOTICE


The District will consider and act upon the following matters:

1. Call meeting to order.
2. Roll call and establish quorum.
3. To approve Minutes of prior meetings(s).
4. To receive a report from the District Bookkeeper and to review and take action on the Treasurer's Report.
5. To review and take action on granting exemptions for 2018.
6. To review, discuss and take action to pay District bills and authorize fund transfers required for operations.
7. To review and discuss progress in move of District financial accounts to Icon Bank and take any necessary action related thereto.
8. To receive, discuss and take action on the Fire Operations Report.
9. To receive a report from Martinez Architects and take any action related thereto.
10. To receive a report from Brad Dill of BD Realty and take any action related thereto.
11. To receive, discuss and take action on engaging Weisser Engineering to act as the District's civil engineer for the Station 2 construction project.
12. To receive, discuss and take action regarding a partial remodel of the stations countertops and kitchen area.
13. To review, discuss and take action on submittals by the Department of thirty (30) day advance request(s) for purchase of items necessary for District operations.
14. To review and take action on approval of expenses related to upcoming firefighter training classes, course materials, equipment and related expenditures to be incurred by the District.
15. To reconsider the District's prior action taken in December of 2017 related to the adoption of the Harris County Fire Code and take any necessary action regarding same.
16. Administrative Reports and Committee updates.
 - a) To review and take action on any report(s) from the District committees concerning and take action as necessary.
 - b) To review, discuss and take action on any proposed Policy, Procedures and Operating Guidelines that require modification.
17. To discuss any new items that need to be on the agenda for the subsequent District meetings and to set the date for the next regularly scheduled meeting for May.

18. To meet in Closed Session pursuant to Government Code §551.071 to consult with legal counsel regarding pending or contemplated litigation, settlement offers or on matters which require confidentiality under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas.
19. To meet in Closed Session pursuant to Government Code §551.072 to deliberate regarding real estate matters.
20. To meet in Closed Session pursuant to Government Code §551.074 to discuss personnel matters.
21. Reconvene in Public Session.
