

Ordinance No 11

Relating to the licensing and keeping of dogs and to prevent the same of running at large and to authorize the destruction thereof in a summary manner.

The Village Council of the Village of New Munich do ordain as follows:-

Section 1

That the owner or keeper of any dog shall annually procure a license for each dog so owned or kept within the limits of the Village of New Munich, Minn.

Section 2

Every owner or keeper of any dog as aforesaid shall within eleven days after the publication of this ordinance and annually thereafter on or before the first day of August of each and every year cause such dog to be described, registered and numbered by the Village Clerk of Recorder of such Village and shall cause each dog as registered plainly marked thereon.

Section 3

Every Person requiring a License under this ordinance of this ordinance shall pay annually as follows:-

For each Male dog the sum of one dollar (\$1.00)  
 " " Female " " " " " " " " " " (\$0.50)

Section 4

Upon the payment of the sum required by the provision of this ordinance by any person to the Treasurer of the Village of New Munich the Treasurer shall thereupon forthwith make out and deliver to such person his official receipt therefor stating the time, amount and for what purpose the same was paid.

Section 5

Upon the presentation and filing with the

of the Village of:

County, Minnesota.

Village Recorder or Clerk of the receipt of the Village Treasury as provided in Section 4 of this ordinance it shall be the duty of Village Recorder or Clerk, forthwith to make and deliver to the person named in such receipt a License signed officially by such Village Recorder or Clerk who shall receive therefor out of the Village Treasury a fee of twenty-five cents (25 cts)

Sec. 6.

It shall be lawful, and it is hereby made the duty of the Village Marshall of the Village of New Munich after the tenth day of August 1917 and all times thereafter to destroy all the dogs running at large in said Village which are not licensed, Registered and numbered as provided in this, and may any Marshall so destroying any such dog shall receive therefor out of the Village Treasury the sum of Fifty cents (50 c), for each dog so destroyed upon filing with the Village Recorder or Clerk an affidavit, stating the time when, and place where, and number of dogs so destroyed. Every owner or keeper of any dog who shall not cause the same to be licensed, Registered and numbered as aforesaid prior to the 10th of August - 1917 and annually thereafter shall upon conviction thereof be punished by a fine of not less than \$2.00 (two dollars) not more than Ten dollars (\$10.00) together with the cost of prosecution and in default of payment thereof shall be committed to the Village Jail or the County Jail of Stearns County - Minnesota not exceeding twenty - days

This ordinance shall be in force and take effect from and after its passage and publication.
