DEADLINE for Entry Form: Monday, July 21, 2017

You need **3 copies of front page of entry form** and 1 copy of the instructions and rules page

1. One copy of front page, entry fee and photo for each quilt entered to:

2. One copy of front page entry form with photo to be attached to each quilt when brought to intake.

3. One copy of front page entry form with photo as a claim receipt to pick up each quilt you enter.

Entry fee per quilt: \$10.00 for non members -----\$5.00 for members

I. Quilt Acceptance Rules:

- a. All entries require marked **CATEGORY #** and are accepted on a first come basis per entry due date and space availability.
- b. Quilt has not been shown in the LSHQG Quilt Show in the past 2 years.
- c. The show committee reserves the right to re-categorize an entry or limit the display of a distasteful entry.
- d. Photos of quilt on each entry form with name, ph# and title of quilt on back (scanned or computer OK)
- e. Required: **4" diameter sleeve stitched to the back top of quilt; 2" diameter sleeve for Small Quilts.**
Not required on Antique Quilts.
- f. Quilts are to be clean and smoke free. Cleaning does not apply to antique quilts, but airing would be good.
- g. Awards may not be given in each category, dependant on the quality of the entries and/or number of entries submitted.
- h. **Sign Hold Harmless Agreement on Entry Form. Quilts cannot be accepted without your signature.**

II. Instructions for Quilt Delivery:

- a. **Baste identification label with name, title of quilt and ph#, on lower back corner of each quilt.**
- b. **Submit second copy of entry form with photo when quilt is submitted.**

III. Drop off or shipment of quilts
