



## Approved Paint Palettes (updated & approved June 30<sup>th</sup>, 2024)

### How to Obtain Approval to Repaint Your House in Casa del Cielo (CdC)

1. **Choose your colors.** Casa de Cielo residents have their choice of using five custom paint palettes which may be found in color on the Scottsdale Ranch Community Association (SRCA) website at [https://www.dunnedwards.com/colors/archive/color-ark\\_pro/scottsdale-ranch/casa-del-cielo](https://www.dunnedwards.com/colors/archive/color-ark_pro/scottsdale-ranch/casa-del-cielo).

You may also visit the SRCA Community Center for paint samples or go to any Dunn Edwards store. All colors are listed using Dunn Edwards paint codes, but you may go to other paint stores and instruct them to use the Dunn Edwards colors.

### Front Door Color Palette Options with Guidance:

The palettes can be paired with the following front door colors below:

<u>SRCA Palettes</u>	<u>Door Colors</u>
2, 4, & 10	Only Wild Mustang DEA161, Sunken Ship DEA148, and Spiced Berry DEA149
11 - 15	All door colors <u>except</u> Sunken Ship DEA148
13 - 15	<u>Only</u> Made of Steel DET593, Dark Pewter DE6134, Weathered Brown DEC756, and Spiced Berry DEA149
All SRCA Palettes	Black DEA002

### **Guidance:**

- 1) Each palette contains options for primary colors and trim colors.
  - 2) Primary and trim colors from different palettes may NOT be used together.
  - 3) A primary color must be used for the house body color.
  - 4) As a trim color, you may choose the body color, one of the primary colors not used on the body or a trim color.
  - 5) The chimney and chimney cap must be painted with either the house body color or trim color, except that houses with blue tiles may paint their chimney cap a matching blue.
2. **Please complete and submit an application to Scottsdale Ranch Community Association (SRCA)** noting all pant color choices and where each color will be used along with a photo of your home. You must complete an application and receive approval even if you are **repainting your house the same color**. This is the only way to ensure that your house file is up to date and for you to know you have complied with SRCA and CdC rules.

SRCA will review your application and forward it to the CdC Architectural Control Committee (ACC) for its approval. You will be notified via email when you may begin your project.

Please allow **up to three (3) weeks** prior to your desired project start date for SRCA and CdC to review and approve applications.
