ORDINANCE AMENDING ORDINANCE NO. 85-7 ESTABLISHING RATES FOR THE PURCHASE OF CEMETERY PLOTS WITHIN THE VILLAGE OF CHAPIN

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF CHAPIN, MORGAN COUNTY, ILLINOIS:

WHEREAS, the Village of Chapin, Illinois, passed and approved Ordinance No. 85-7, an Ordinance Regulating Headstones in the McKinney Addition to Chapin Cemetery and such Ordinance is currently in effect and in existence; and

WHEREAS, it is necessary that said Village now amend Ordinance No. 85-7 to establish fees for the purchase of cemetery plots at the Chapin Cemetery;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Chapin, Morgan County, Illinois:

SECTION 1. Ordinance No. 85-7 is hereby amended by adding Section 7 to said Ordinance as follows:

SECTION 7. Plot Fees. The plot fees for cemetery plots in the Village cemetery as of May 8, 1996 are established as follows:

Residents:

\$300.00

Non-Residents:

\$600.00

SECTION 2. All ordinances or parts of ordinances of the Village of Chapin, Illinois, conflicting with this ordinance, are hereby repealed to the extent of such conflict.

SECTION 3. This Ordinance shall be in full force and effect from and after it passage and approval as provided by law.

SECTION 4. If any section, paragraph, clause or provision of this Ordinance shall be held invalid, such invalidity shall not affect any other sections, paragraphs, clauses or provisions herein.
