# BEFORE APPLYING: DOING YOUR HOMEWORK

Applying for a school license requires a considerable up-front investment and a long-term commitment. We recommend taking the time to do the homework before getting started, which includes:

- Conducting research on the schools in the area where you are planning to open.
- Assessing the programs offered and the community needs not being met.
- Confirming the employment projections for your specific market.
- Calculating the costs of establishing and operating your school and programs.
- Confirming if any of the programs to be offered require board or facility approval.
- Watching the CIE's commission meeting webcasts. <u>CIE Meetings</u> are conducted every other month. You will learn immensely by watching the commissioners and common situations schools face. You may watch the meeting via YouTube. Follow the instructions included on CIE's Meeting Agenda page.
