Masks are mandatory when in the building.

- Check in at entrance desk to receive armbands.
- Then, proceed to gate steward for armband # check-off on board.
- Use mats provided for crates and chairs.
- Social distance 6' from others. There will be lines on the floor when needed, or gates separating you from the workers.
- Warm up area at ringside is for next dog in the ring only (dog on deck). This is your space and time to get ready to enter the ring.
- All other exhibitors and dogs will wait until dog before is in the ring.
- All surfaces will be wiped down after each entry. All equipment will be handled by gloved stewards.
- You will handle your own leash and dumbbell.
- Please wait to place your article bag on the chair until it is sanitized after the dog before you is finished.
- Cones will be used for figure 8 posts.
- All qualifiers will be called back to ring for awards after the class is complete; please keep the 6' distance from each other.
- You may pick-up ribbons at the ring exit after awards are announced (this is self-serve).
- When your class is finished, please leave the building and remove your crate so the next group will have space to put theirs.
- There is a separ No non-entered dogs are allowed in the building.
- Please be respectful of these guidelines and those set by Federal,
 State, and the AKC committee to allow us to safely provide this show.


From I-94:
