



# Coyote Creek Farm

## *Liability Release / Hold Harmless Clause*

The undersigned rider/visitor/buyer and any signing parent or guardian hereby (1) agrees to release the management of this farm, their officers, directors, employees, members, or agents, and the owners or managers of the farm, from any loss, damage, liability, or injury arising out of or resulting from this facility or rider/visitors presence therein; (2) agrees to indemnify, hold harmless and defend Hope Thomas, dba Coyote Creek Farm, facility owner, and the management of this farm from and against any and all claims for loss, damage, liability, or injury, however caused, resulting directly or indirectly from rider/visitor's entry or participation in any activities upon this property; and (3) acknowledges that activities with and around horses, dogs, and horse shows involve inherent risks that are understood by the persons signing and are expressly assumed. In the event of injury to rider/visitor or to rider/visitors' animals, permission is hereby granted to management for emergency medical treatment. Furthermore, all riders/visitors agree that they participate voluntarily in the farm activities fully aware that horse sports and activities around horses involve inherent dangerous risk of serious injury or death, and by participating they expressly assume any and all risks of injury or loss, and they agree to indemnify and hold harmless Coyote Creek Farm, its owner, directors, employees, and agents from and against all claims including for any injury or loss suffered during or in connection with the farm activities or personal property of the farm, its boarders, owner, and/or agent (including, but not limited to horses, other pets, tractors, etc...), whether or not such claim, injury, or loss resulted, directly or indirectly, from the negligent acts or omissions of said owner, directors, employees, or agents of Coyote Creek Farm.
