ORDINANCE NUMBER 6
SERIES OF 2002

AN EMERGENCY ORDINANCE OF THE TOWN OF MARBLE,
COLORADO, SUBMITTING TO THE REGISTERED ELECTORS VOTING
IN THE REGULAR MUNICIPAL ELECTION TO BE HELD APRIL 2, 2002,
AND QUESTION CONCERNING THE SALE OF TOWN HALL.

WHEREAS, C.R.S §31-15-713(a) requires municipalities to submit to the electors the question of whether to dispose of real property used or held for governmental purposes; and

WHEREAS, the Town of Marble has acquired the Marble City/State Bank to use for Town Hall; and

WHEREAS, the building located at 407 West Main, Marble, Colorado, is no longer needed for Town Hall; and

WHEREAS, by Ordinance Number 8, Series of 1995, the Board of Trustees submitted a ballot question to the registered electors of Marble requesting the authorization to collect, retain, and expend in fiscal year 1995 and in each subsequent year the full amount of revenues generated by all of the Town's revenue sources, including without limitation state grants, sales taxes, license fees, and development fees, without any increase in the property tax mill levy; the sales tax rates, or the rates of any other taxes currently imposed by the Town. And notwithstanding any state limitation on revenues and expenditures, including the limitations of Article X, Section 20, of the Colorado Constitution; and

WHEREAS, the above question was submitted to the voters and passed by the majority of the voters at the coordinated election of November 7, 1995; and

WHEREAS, the question in Ordinance Number 2, Series of 2002 was unclear as to whether the land should be included in the sale of Town Hall; and

WHEREAS, the Town of Marble, Colorado, will hold its regular municipal election on April 2, 2002

NOW, THEREFORE BE IT RESOLVED, by the Board of Trustees of the Town of Marble, Colorado, that:

1. Ordinance Number 2, Series of 2002 is hereby repealed.
2. The following revised question shall be submitted to the regular electors voting in the April 2, 2002 regular Marble Election:

Shall the Town of Marble be authorized to sell Town Hall (407 West Main, Marble, Colorado, 81623) and the Lots upon which the building is placed (Lots 14, 15, 16 and 17, Block 17, West Marble) and allowed to spend such revenue in accordance with Ordinance Number 8, Series of 1995?

3. At the April 2, 2002 municipal election, the official ballot, including absentee ballots, shall state the question to be voted upon as set forth above.
4. If a majority of all the votes cast at the election shall be in favor of the question, the measure shall be deemed passed, and the Town of Marble shall be authorized to sell Town Hall to the highest bidder.


READ, PASSED AND ADOPTED by a vote of 4 to 0 this 5th day of March, 2002.
