# Minutes of Mandalay at South Mountain (Quintessa), Phase II, HOA Quintessa Board Meeting—Saturday, February 2, 2019 Prepared by Wendy Sandor

#### **Members in Attendance:**

**Call to Order:** The Board of Director's regular session meeting of the Mandalay at South Mountain, Phase II, HOA held at the community Ramada on 23<sup>rd</sup> Street, Phoenix, Arizona was called to order at 9:00 a.m. with President Camilo Acosta presiding.

**Approval of Minutes:** The minutes of the Saturday, December 1, 2018 Regular Session were approved.

**Financial Report:** The financial report reflected an Operating account of \$8,068.13 and a Reserve account of \$27,854.32 for a Total Asset balance of \$35,922.45. It was reported that expenses were under budget overall, with the exception of repairs and maintenance.

# **Architectural Requests:**

• Lot 6 Outdoor BBQ Structure was approved.

### **Issue/Response Tracking:**

- Winston Entry Gate—waiting on repair to gate safety loops.
- Call Box—needs verification
- Leaking Fire Hydrate on corner of Samantha Way and 23<sup>rd</sup> Pl—Board will call city on Monday

#### **New Business:**

- Winston Gate Safety Loop Repairs—the Board filed a claim with the City of Phoenix from Phoenix Fence for \$1800 to fix loops. Work is to be conducted in 2 weeks.
- May Annual Homeowners Meeting—the meeting is scheduled for Saturday, May 11<sup>th</sup> at 9:00 am. Two mailings will go out: 1) nomination ballots and 2) voting ballots.
- 2019 Budget—The 2019 budget will reflect an HOA fee increase to \$200. A historical perspective was given to outline the 3 increases over the last 9 years from \$120 → \$150 → \$180. Budget overviews were printed out for homeowner attendees.

#### **Old Business:**

• Block Watch Grant Committee—Initial meeting to start the grant process for 2020 is scheduled for Wednesday, December 5<sup>th</sup>, 2018. Wendy Sandor, representing the Board will meet with Charlotte Berryman to scope out the process.

• Community Wall Painting—Quotes from other companies will be obtained as the one received was too high.

## **Open Forum:**

- Discussion of homes needing exterior painting. Discussion of a phase in plan of action for homes painted 10 or more years ago. Letters will be sent out to those homeowners indicating the need to paint this calendar year.
- Homeowner complaint of holiday decorations still out on some homes. The Board will email those homeowners for removal.
- Homeowner reported an irrigation leak on 23<sup>rd</sup> Pl.
- Discussion of adding rain sensors to irrigation. The Board will talk to the landscapers.
- Homeowner noted the retention basin not draining quick enough, possibly due to irrigation. The Board will follow up.
- Plant Replanting Budget = \$3480
- Discussion of an April Community Clean-up. The Board will plan a day.
