

## **COMMITTEES, CHAIRS AND OBJECTIVES**

## **FAPIA BYLAWS, ARTICLE XI = RE: COMMITTEES**

- Section 1. There shall be six (6) standing committees designated to serve. They are as follows: Membership, Ethics, Public Relations, Convention, Legislative, and Past-Presidents. The duly charged goals of each committee, with their Officers in Charge, are a part of these Bylaws by attachment.
- Section 2. Members of all committees shall be appointed by the incoming President for the upcoming year of service at the incoming President's inauguration meeting.
- Section 3. The Officer in Charge (OIC) of each committee will be its Chairman whose duty it will be to direct the activity of their respective committee. Additionally, the OIC will direct the preparation of its committee's Activity Reports, that will be created for presentation at quarterly, semi-annual, and annual meetings.
- Section 4. Each committee shall work to meet the goals set by the Board of Directors and work to enhance the goals of this Association. Committees and their goals are, as follows:

MEMBERSHIP: Chair—BOD Treasurer: Craig Drillich The goals of this committee are to increase membership, maintain a current membership list, and to ensure quality control in the application process.	ETHICS: Chair—BOD Vice President: Jimmy Farach The goals of this committee are to review the Code of Ethics and Conduct as required by the Florida Department of Financial Services (DFS), Florida Association of Public Insurance Adjusters (FAPIA), and Florida Statutory and Administrative Requirements, making sure that FAPIA is in compliance with all DFS standards.	PUBLIC RELATIONS:  Chair – BOD Secretary: Tim Cornett  The goals of this committee are to prepare news releases on Association business, to assist as needed with, the Association's Newsletter and website, and to assist as needed with any needed PR or advertisements at the time of any major catastrophe.
CONVENTION: Chair – President-Elect: Don Phillips The goals of this committee are to organize and prepare the Annual and Semi-Annual Conventions for the association.	CONTINUING EDUCATION: Interim Chair- Joseph Connelly This committee's goals are not outlined in the bylaws, however, it is understood that the committee is responsible for working with speakers and the stated school official in coordinating the continuing education offerings of FAPIA events that include CE's.	PAST PRESIDENTS: Chair – Immediate Past President: Darryl Davis The goals of this committee are to provide special counsel to the president and take on special projects as are designated by the president. All past presidents shall be entitled to attend and participate in all Board of Directors meetings without individual votes. However, the committee shall have one (1) vote as a body. Majority vote, within the committee, shall be cast as the committee's vote by the most Immediate Past President.
UNLICENSED PRACTICE OF PUBLIC ADJUSTING (UPPA): Chair – Director: Craig Drillich This is an ad-hoc committee, also not outlined in the bylaws. It's goal is to review complaints received about potential UPPA violations in Florida to make sure they meet the threshold required for prosecution of "clear and convincing". The committee then instructs the managing director to submit reports about those complaints that meet the threshold to DFS and/or DBPR, as necessary. The committee's work is meant to help stem the increasing tide of UPPA violations in Florida.	COMMUNITY AFFAIRS COMMITTEE — Chair: Karen Schiffmiller This committee has been given the task of working on campaigns in communities throughout Florida to provide the public adjusting industry an opportunity to help their local communities. In Sept 2014 they launched the "Public Adjusters Pay It Forward" campaign which has resulted in donations of over \$8,000.00 to local charities, so far.	FUNDRAISING Committee Chair: Secretary, Jimmy Farach The fundraising committee secures sponsorship opportunities for the association by meeting with potential sponsors and promoting the benefits of the FAPIA programs available to them.
