The English Springer Spaniel described above is sold for the sum of \$

This puppy is sold with Limited Registration Papers, a non breeding contract.

The buyer agrees to have the said puppy neutered and **send proof of this procedure to the breeder from the veterinarian.**

Puppy is defined here to be an English Springer Spaniel puppy which is in good health at the time of transfer, and embodies the characteristics of the English Springer Spaniel Breed. The Puppy is purebred and is registered with the American Kennel Club.

The BREEDER guarantees the above-described dog to be healthy at the time of sale. The BREEDER does not assume any liability for any injury to said puppy after delivery. The BUYER agrees to have this puppy examined by a veterinarian within 72 hours of delivery. If the Puppy is found to be other than healthy by the BUYER'S veterinarian, it shall be returned to the BREEDER immediately, and the purchase price will be refunded. Deadline for this refund is 72 hours after time of BUYER'S vet check. Shots for the Puppy are given by the BREEDER at 7 weeks old.

This puppy has a 1 year guarantee against genetic defects causing death. In case of death resulting from genetic defect, the BREEDER will replace Puppy, with a puppy of equal value. All Veterinarian records are required to be sent to BREEDER prior to replacement. The BUYER agrees to maintain the Puppy's health in good condition, and to provide yearly examinations, vaccinations, heart worm tests, and any other usual procedures necessary to assure good health. The BREEDER does not guarantee fertility on puppies sold with full registration.

The BREEDER has done everything possible to produce healthy sound puppies both by breeding only dogs (parents) registered by the AKC and by raising puppies in the best way possible in regards to diet, exercise, socialization and veterinary care. There are many factors that can influence growth and development, such as diet, exercise, weight

gain, etc. The BUYER assumes the responsibility to carry on with the appropriate vaccinations, exercise and feeding schedule, as supplied by the BREEDER. Most particularly, the BUYER agrees to keep the puppy slim throughout its normal growth period. The BREEDER recommends dog food with at least 25% crude protein and 10% crude fat and no grain. The BREEDER can offer no further guarantees once the care of the puppy is no longer under their control.

The BUYER hereby agrees that if at any time the BUYER cannot take proper care of the puppy, the BUYER must contact the BREEDER and the BREEDER will have the first choice to either: (a) take the puppy back or (b) assist the BUYER in finding a suitable home for the puppy.

The BREEDER neither makes nor implies any warranties or guaranties other than those written in the agreement including, without limitation, the warranties of merchantability and fitness. This document constitutes the entire agreement between the BREEDER and BUYER with respect to this sale. The BUYERS signature below indicates that he/she has read, agrees and does understand all the conditions of the sales agreement and contract of sale.
