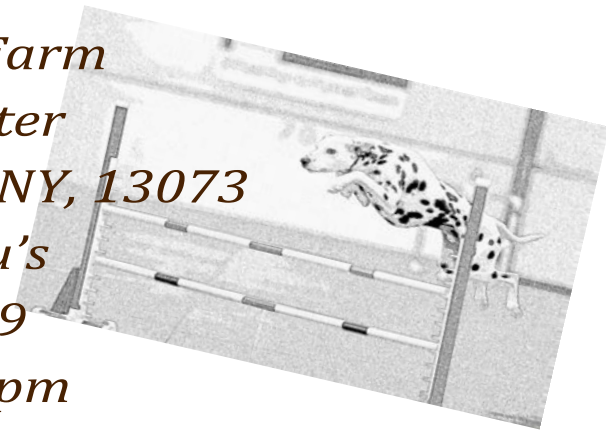

It's time to bring your dog, train and have fun at our Run Thru's on Sunday, October 27, 2019. Pre-registration cost is \$7 per run (90 sec) or Day of Event cost of \$9 per run. Each run shall be 90 seconds in the ring. Payment can be made on the day of the event or sent with pre-registration form. Please make check payable to Paws for Thought Farm, LLC.

We plan to have 5 – one hour time slots running from:

Each hour time slot will allow 5 minutes to walk the course at the beginning of the hour. There will be 20 – 90 second slots allowed for pre-registered runs and 4 – 90 second slots for Day of Event Entries. There will be a set number of 24 runs per hour. There is no guarantee of adequate time available for Day-of Event entries. Therefore, it is best to pre-register your time. Due to the limited number of entries per hour, registration will be on a first come – first serve basis. PFTF will send out confirmation emails to notify actual registration in each hour.

We will be looking for volunteers to help with the activity. Volunteers will receive free drinks and the free use of a TR Crate Rental Crate. Please let us know ahead of time if you are willing to volunteer so we can assign your dog a crate. Crate rentals will not be available for the event.

We plan to have a nested (EX/MAS and NOV/OPEN) course set up for the event.

If you have already signed a waiver there is no need to sign another form.

Rules During Event

- 1) In order to prevent potty accidents on the turf, dogs must be thoroughly exercised outside prior to entering the ring.
- 2) In the event of a potty accident, it must be cleaned up immediately. A clean-up kit and instructions on how to clean-up an accident is located at the gate entering the ring. Paws for Thought Farm Management must be notified prior to Participants leaving the Premises. There is a \$5.00 Potty Fee for all potty accidents
- 3) Although clean treats are allowed for training while in the ring, any excess food that is not eaten must be picked up immediately. Excess treats must not be left in the ring. Failure to pick up excess treats will result in the loss of the ability to use treats during training.
- 4) Clean shoes must be worn at all times on the turf. Participants must bring clean, spare shoes to wear while inside the building.

**INDIVIDUAL RELEASE AND INDEMNIFICATION AGREEMENT
WAIVER, ASSUMPTION OF RISK AND AGREEMENT TO HOLD HARMLESS**

I understand and acknowledge the following to be an inherent aspect of my voluntary participation in dog sports:

- 1) That attendance at a Paws for Thought Farm, LLC training session, sporting event, or any other function or practice (formal or informal, including use of the facility, event grounds and equipment) is not without risk to myself, members of my family, any person accompanying me, or my dog, because some of the dogs to which I (we) will be exposed, including my own, may be difficult to control and may be the cause of injury even when handled with the greatest amount of care.
- 2) That there is a risk of utilizing any type of training or sporting event equipment selected for such purpose, especially such equipment designed and used for the sport of dog agility.

In consideration of the above:

I hereby waive and release Paws for Thought Farm, LLC, its owners, trainers, employees, officers, and agents from any and all claims for injury to damage (Including legal fees) which I, any member of my family, any person accompanying me, or my dog may suffer, including specifically but not without limitation, any injury or damage resulting from the action of any dog, including my own, contact with or use of any equipment, property fixtures, training fields or event grounds and surrounding areas thereto and I expressly assume the risk of any such damage to injury while attending any Paws for Thought Farm, LLC sponsored training session, sporting event or other function.

I further agree to hold Paws for Thought Farm, LLC, its owners, trainers, employees, officers, and agents harmless from any claim or loss of my dog(s) by disappearance, theft, death or otherwise, and from any claim for damage to injury to my dog(s), whether any claim be caused by the negligence of Paws for Thought Farm, LLC or any of the parties aforementioned.

I also agree to defend, indemnify and hold harmless, Paws for Thought Farm, LLC, its owners, trainers, employees, officers, and agents and shall personally assume any and all responsibilities and liability for any loss or injury which may be alleged to have been caused directly or indirectly to any person, dog or property by the act of my dog, myself, my family member or any other person accompanying me while participating in a Paws for Thought Farm, LLC sponsored training session, sporting event or other function, formal or informal, held at any training field or event grounds.

I also understand and agree to accept responsibility for the control of any dog in my care and custody at all times while attending any Paws for Thought Farm, LLC sponsored training session, sporting event or other function, whether formal or informal.
