INTERVIEW OF SUSPECT

HEATH CARLTON STOCKS W/M, DOB: 771 JOHNSON ROAD LONOKE, AR 72086 NO PHONE

HEATH STOCKS was interviewed by Inv STEVE FINCH, Lonoke County Sheriff's Office, on 1-20-97 beginning at 2:08 p.m., at the Lonoke County Sheriff's Department. No one else was present during the interview.

STOCKS was advised of his rights on a standard Rights form. STOCKS initialed and signed the Rights Form indicating he understood his rights. After completing the Rights Form, STOCKS gave the following statement.

"On Friday, January 17, 1997, I had gone to eat at Western Sizzlin' with my Grandmother and Grandfather STOCKS, my uncle J.T., and my Aunt BONNIE. We got back to my grandparents house about 8:00 p.m. I stayed there for a few minutes, then I went to my house at 771 Johnson Road, Lonoke. I started watching television, but there wasn't much on, so I turned it off. I sat on the couch in the living room. I started thinking about all the trouble my dad and I were having and I started crying and I started getting mad. I got a .45 cal. automatic pistol that my Dad kept in his gun cabinet and another clip. I put the extra clip in my pocket. I didn't think it had any bullets in it. I knew the gun was loaded. I carried the gun with me as I went from room to room, messing up the house. In Mom and Dad's room, I emptied out drawers and I hit their T.V. with a golf club. I got the combination to the safe out of the encyclopedia, the 'S' volume, and opened the safe. I scattered the papers around. I knocked over the ironing board. I think I messed up all the rooms except for mine. All the time I was doing this I kept thinking and kept getting mad. After I messed up the house, I tried to kill myself. I put the barrel of the gun in my mouth, but I couldn't pull the trigger. I did this twice. Between

these two attempts, I had gone out to my car and sat in it for a few minutes. Sometime between 10:00 p.m. and 10:30 p.m., I was standing in the living room with a gun in my hand when HEATHER came in the front carport door. HEATHER saw the mess in the house and said she was going to call '911' because she thought someone had broke into the house. She had the phone in the hand when I told her not to. I told her to leave. She hung the phone up. At this time, Mom and Dad came in the carport door. They both saw how the house was messed up and I think Mom said call '911'. I was still in the living room and I ran into the kitchen. I saw Dad with the phone in his hand, and I started shooting. I shot my Dad first, and I just kept on shooting until Mom, Dad, and HEATHER were all on the floor. I remember shooting my Dad in the head after he was on the floor, but I don't remember shooting the others after they were down. After the shooting was over, I got scared. I remember picking up the shell casings that I could find, and I put them in my coat pocket.

I went out to my car, then I went back to the house. I kicked open the front door of the house and I got the jewelry that was in the safe, and I think I got some from HEATHER's room. I put the jewelry in a white plastic trash bag. I remember that I prayed in the kitchen, I begged God to bring them back.

I then got in my car and I left. I went to Arkadelphia. I was scared and I wanted to see my girlfriend, JAN.

When I got to Arkadelphia, I threw the gun out the window as I was crossing over a bridge. I think the bridge was near the Caddo River. I then drove to the Pizza Hut and threw the bag of jewelry in the dumpster that was in the parking lot.

I left Pizza Hut and went to Feaster Trail that is near the campus of Henderson State University.

I put the gloves that I was wearing in a trash can near the trail. I threw the shell casings, the clip, and a Buck knife in a stream near the trail.

After this, I went and got some gas, a coke, and some Skoal. I then went to the apartment I used to have at Henderson University. I followed somebody in and I went to my old apartment, number 416.

My old roommate, KEITH ANTHONY, was not there, so I went to apartment #415. KELLI CUNNINGHAM lives there. She is a friend of mine. I was there until STEVE FINCH and MARK HOLLINGSWORTH got there to tell me about my parents and my sister."
