### **Attendance:**

### **Opening – Brian Boehm:**

- Brian called the meeting to order at 7:00 pm with the Pledge of Allegiance.

### **Treasurer's report – Bill Means:**

YTD Income is \$20,802 and expenditures of \$10,839. Income from the rental property totals \$2,288. Total fund assets are \$50,499 which includes the \$18,000 CD.

### **Membership report – Brian Boehm:**

- Last month 85 members – 76 Regular & 9 Senior. \$720 dues were collected, and 4 notices have been issued. Four members submitted dues credits.
- Three new members second reading – Gary Olsen, Dave Holman & John Lathrop – Sponsor Dave Christenson. They were voted in via voice vote.

### **Rifle Team – Jon Speck:**

- In the USA Shooting matches held on July 11<sup>th</sup> in MN, Emme placed 3<sup>rd</sup><sup>th</sup> and Dylan placed 2<sup>rd</sup> in the 3P match. In the afternoon prone match, Dylan was High Jr. and match winner.
- Our juniors will be competing in the ASSA national matches beginning Saturday, July 25<sup>th</sup> as well as matches in IL and Michigan in the coming weeks.
- The Junior Olympics have officially been cancelled. Several of our juniors had received invitations to the JOs which is held in Colorado Springs, CO.
- Three of our club members will be competing in the 300 Meter Nationals in September in MN.
- The rifle team has restarted Thursday evening practice.
- At this time, it is expected the smallbore fall leagues will start on time the beginning of October.

### **Pistol League – Bill Means:**

- Members stopped shooting in March. The consensus is to begin the Fall League as the layout of the range provides proper distancing for shooters. More information will be disseminated at a later date.
