I understand that I will pay tuition for those two weeks, and no refunds will be issued for tuition already paid for the month. A \$150 registration fee (non-refundable) is required to secure a spot in a classroom. In addition, I understand Semester Supply Fees of \$150 per semester will be due on September 30th and January 31st. LATE FEE POLICY: Tuition payments made after the 10th day of any month will be assessed a \$50.00 late fee. If my child's tuition payment is more than 60 (sixty) days late, interest on the amount delinquent will accrue at the rate of 6% per month.

If you need a different tuition due date other than the 1<sup>st</sup> of each month, or you need to split the monthly payment, please schedule this with the director.
