<u>ASSESOR REPORT</u> - Supervisor Thelen congratulated Beth Botke on her perfect report from the State on the AMAR Audit. Tax Roll is ready to go and post cards are sent to those residents whose property will be measured

OLD BUSINESS

<u>Attorney William Fahey</u> – Mr. Fahey was present to answer questions of the board for obtaining him as the township lawyer. There will be no retention fee only a fee for work actually done and for phone calls which will be billed in 6 minute increments. The board had a short discussion after the presentation and the motion was made by Kindel to retain Attn. Fahey with the stipulation that there will be the Clerk, Supervisor and Treasurer's approval before a call to the township lawyer is made seconded by Smith, motion carried.

Silvers Road Property - Everything is on schedule and proceeding according to plans

<u>Electric bids</u> – As motion was made last month to accept lowest bid for electrical upgrade of the town hall and that bid was Community Electric in the amount of \$1660.00 there will also now be a small additional amount due to the fact that there might be a few additional upgrade that might occur.

<u>Road Report</u>- Most gravel has been spread and the second coat of chloride is going down tentatively July 9th. Road side cutting on the main paved roads and the corners has also been done. All other roads if property owners want the road side cut they must do them themselves.

Supervisor Thelen has been in contact with residents who have voiced their concerns with Searles and E. B. Ridge truck routes on our township roads.

<u>Additional Public Comments</u> - Jean Bradley then addressed the situation with the hauling of gravel from Searles pit they are using Scott and Kinley Roads instead of haul routes to get to their pit on Airport Road. She stated that as many as 70 trucks a day have been going roads. She also stated that she had gone to the zoning commission meeting this month and they will be looking into this situation and reviewing the site plan with the Road Commission for Searles Gravel Pit on Williams and Avery Rds. This item might possibly be on the agenda at the Zoning's July meeting.
