This office received your Request for Investigation, however, the allegations in your complaint are insufficient to warrant review by the Commission. Accordingly, after careful review by the staff, this matter is being closed under the authority of the Grievance Administrator pursuant to Michigan Court Rule 9.112(C)(1)(a).

I have reviewed your complaints as to Mr. Weglarz. Essentially you allege that Mr. Weglarz failed to keep you informed, failed to advise that your second attorney would be representing you at the final settlement conference, are unhappy with the settlement amount and have not been provided with copies of your file. The transcript you provided reveals that you agreed to the settlement. The mere fact that, in retrospect, you regret entering into this settlement, does not provide evidence of misconduct. Although you claim you were not fully advised of developments, you have not explained what developments took place and how Mr. Weglarz's failure to inform you impacted your case. Further, your acceptance of the settlement on the record with another attorney as your representative does not substantiate your claim that you were unhappy that Mr. Weglarz was not present. Finally, an attorney is entitled to compensation for the cost of copying your file.

Mr. Weglarz has been provided with a copy of your Request for Investigation.
