House Bill 2025 which amends ARS 15-184 and 15-341 was passed in May 2022.

The new section of ARS 15-184 states that "a charter school governing body must develop and adopt in a public meeting policies to allow for visits, tours and observations of all classrooms by parents of enrolled pupils and

parents who wish to enroll their children in the charter school unless a visit, tour or observation threatens the health and safety of pupils and staff.

Lisa Fink made a motion to Motion to Approve Policy for school tours and Visits Ray Malnar seconded the motion. The board **VOTED** unanimously to approve the motion.

C. Procedures for opt in for any instruction, learning materials or presentations regarding sexuality, in courses other than formal sex education curricula.

Lisa Fink presented that a new Arizona statute dictates procedures that each school should have in regards to instruction about sexuality. Administration needs to provide

"Procedures by which parents will be notified in advance of and given the opportunity to opt their children in to any instruction, learning materials or presentations regarding sexuality, in courses other than formal sex education curricula."
