

SALARY ORDINANCE 2011-05_{cr}

An ordinance amending the pay rates for elected officials, appointed officials and employees of the Town of Cloverdale for the year 2011. Fringe benefits, vacation, leave and other employment policies of the town are established elsewhere.

In all cases below if a mathematical conflict exists between the stated yearly or weekly rate and a per unit rate, the stated yearly rate controls.






