 - a. Universal and correct wearing of masks: All staff and students in grades KG- 6th grade must wear masks. Teachers have the option of mask or face shields. Students and staff who do not have a mask upon entry as given one when they enter the building.
 - b. Physical distancing (e.g., including use of cohorts/podding): Our school is a smaller school. All kids attend daily and each desk is socially distanced. Students also have desk shields.

Student Physical Distancing plans include:

Buses- N/a

Playgrounds/Outside Spaces/Athletics- Students are encouraged to socially distance but still allowed to share equipment. Students sanitize before and after play.

Classrooms: each desk is socially distanced. Students also have desk shields.

Food Service: students breakfast and lunches are placed on a tray and they individually go and pick their lunch up.

Staff: Must wear masks when in common spaces. Must also wear masks or face shield when students are present. May look to allow teachers that are vaccinated to not wear masks, but this will depend on covid numbers in the fall.

Handwashing protocols will include: Students and staff must sanitize upon entry into the building. Must also sanitize when they leave and enter back into the classroom.

Plan to meet cleanliness and disinfecting standards in school facilities and property include: Each day desks will be sanitized by staff mid day and at the end of the school day. All café tables are sanitized between and after use. All classrooms and common spaces are disinfected. An addition custodian will be hired to ensure proper sanitization.

c. Contact tracing in combination with isolation and quarantine, in collaboration with the state, local, territorial or tribal health departments: Local health department will be notified if any cases arise in our building. All students and staff that were in contact with the individual will be notified. If the student or staff member shows symptoms of COVID the staff member will be asked to leave and unable to return until they have a negative Covid test. Student's parent will be notified and strongly encouraged to have student tested.

- d. Diagnostic and screening testing: RSA has testing materials on site for emergency use.
- e. Appropriate accommodations for children with disabilities with respect to the health and safety policies: Students with disabilities will still receive all accommodations In a safe environment that is socially distanced.
