**PAYMENT PLAN PROMISSORY NOTE**

In return for the services performed and received by 1ST OUT 24/7 BAIL BONDS, specifically the posting of bail for \_\_\_\_\_, in \_\_\_\_\_ County, PA, I/We promise to pay to 1ST OUT 24/7 BAIL BONDS and/or its assigns the balance due for posting said bail, in the amount of \$\_\_\_\_\_. This balance represents the original Premium to secure the bail bond from any insurance company utilized by 1ST OUT 24/7 BAIL BONDS, which was \$\_\_\_\_\_.

**PAYMENT**

Payment shall be made in weekly/Bi-weekly/monthly installments, consisting of \$\_\_\_\_\_per installment commencing on \_\_\_\_\_, until the principal is paid in full. Debtor has the right to pay the entire balance at any time without penalty.

**DEFAULT**

Debtor must make payment required by this note within ten (10) days after the due date of each payment. If payments are not made within that time, 1ST OUT 24/7 BAIL BONDS or its agent/assigns may declare that this Note is in default. No Notice of Default is required. Payment made after the ten (10) day period, shall be subject to an interest change of 1.5% per month of 18% per annum and a one-time service charge of 5% or \$25.00, whichever is greater, plus all collection costs, attorney fees, costs of litigation, investigation fees, and bad check fees. If default is made, demand for payment in full will be made. The entire outstanding balance will be subject to the same interest charges, services charges, and other fees set forth above. Furthermore, Debtor understands that, in the event payment of all monies due and owing hereunder are not paid as agreed, 1ST OUT 24/7 BAIL BONDS shall have the right to take any steps necessary to revoke the bail bond posted by them on behalf of said Defendant, and shall be entitled to take said Defendant into custody and return him/her to the authorities from whose custody he/she was bailed.

**WAIVER AND ASSIGNMENT OF RIGHTS**

Debtor gives up right to require that 1ST OUT 24/7 BAIL BONDS 1. Demands payment (called "presentment"), 2. To notify me of non-payment (called "notice of dishonor"), and 3. To obtain an official certified statement showing non-payment (called "protest"). Others who are liable on this Note also give these rights up. 1ST OUT 24/7 BAIL BONDS does not give up the right to declare that this Note is in default, due to any previous delay of failure to declare defaults. Furthermore, 1ST OUT 24/7 BAIL BONDS may assign this Promissory Note or any of its rights and powers hereunder, with all or any of the obligations hereby guaranteed, and may assign and or deliver to any such assignee any of the Security of this Promissory Note, and in the event of such assignment, the party who this Promissory Note is assigned shall have the same rights and remedies as if the originally named herein in place of 1ST OUT 24/7 BAIL BONDS. Should this Note be assigned to a third party for the purpose of collection due at default, Debtor will be responsible for any and all costs listed under the Default section of this Note.

**ENTIRE AGREEMENT**

I understand that this document constitutes the entire agreement between 1ST OUT 24/7 BAIL BONDS and myself, the debtor. 1ST OUT 24/7 BAIL BONDS has made no promises to me other than those in this agreement.

**SEVERABILITY AGREEMENT**

I understand that if any one or more provisions contained in this Agreement will, for any reason, be held to be invalid, illegal, or unenforceable in any respect, such invalidity, legality or unenforceability will not affect any other provision of this agreement, but this Agreement will be constructed as if such invalid, illegal or unenforceable provision had never been contained herein.

The Debtor must promptly inform 1ST OUT 24/7 BAIL BONDS of any change in name or address.
