- 2. Each Vendor is REQUIRED to participate in the staging process there is no exceptions if you do not show up to the staging you will forfeit your booth and booth fees.
- 3. You will receive a map and directions as we get closer to the event for each day of vendor display that you signed up for.
  - a. Street Party: Location McCulloch Blvd
    - i. April 23<sup>rd</sup>, 2020
    - ii. Staging 7:00 AM 11:00 AM Street Party
    - iii. Open from 1:00 PM to 9:00 PM and is FREE to the Public.
  - b. Thunder Alley: Location London Bridge Resort Side of the Channel
    - i. April 24th, 2020
    - ii. Staging 8:00 AM 9:00 AM Thunder Alley
    - iii. Open all day and FREE to the Public, prime time is for the START of the Poker Run the Parade of Power at 11:00 AM.
  - c. Pit Row: Location Site 6 Shootout
    - i. April 25th, 2020 and possibly April 26th, 2020.
    - ii. Staging 7:00 AM to 8:00 AM Pit Row
    - iii. Open all day and FREE to the Public, this is a spectator location for the shootout.
- 4. As a vendor you are responsible for your own booth supplies tables, chairs, lights, power, etc.
