AN ORDINANCE GRANTING CORPORATION EASEMENT FOR WATERLINES IN CERTAIN TOWN STREETS AND ALLEYS.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF MARBLE, COLORADO:

Short title. This ordinance shall be known and may be cited as the "First Waterline Easement Ordinance, 1983".

Ordinance NO. 5, Series 1980, entitled: "An Ordinance Granting Corporation Easement for Waterlines in Certain Town Streets", is hereby ammended to include the addition of those two easements described on Exhibit A attached and incorporated hereto by this reference.

ORDINANCE "S, SERIES 1983 -- EXHIBIT A

GRANT OF EASTWENTS FOR MAFTER LIVES

THIS AGREEMENT, entered into between the Town of Marble, Colorado, a municipal corporation, party of the first part, and The Marble Mater Company, a Colorado non-profit corporation, party of the second part.

WITNESSETH THAT:

For and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration in hand paid, receipt of which is hereby acknowledged the party of the first part has granted, bargained, sold and conveyed unto the said party of the second part, the easement for water lines as described as follows:

First Basement, Centerline

Easement ten (10) feet on either side of centerline described as follows:

Commencing at a point which is the center of the intersection of West Third

Street and the Alley through Block 32 between Park Street and State Street, thence
westerly approximately 366 feet along the centerline of the said Alley, to a point
which is the center of the intersection of West Fourth Street and the said Alley.

Second Easement, Centerline

Easement thirty-three (33) feet on either side of centerline described as follows:

Commencing at a point which is the center of the intersection of West Fourth Street and West State Street, thence westerly approximately 366 feet along the centerline of West State Street, to a point which is the center of the intersection of West State Street and West Fifth Street.

SUBJECT TO all the same terms and conditions of the previous Grant of.

Easements For Water Lines dated July 25, 1980 and recorded in Book 588 and Page
753 - 757 of the records of the Clerk and Recorder of Gunnison County; and

further subject to the provision that an engineering study be made prior to the
start of construction and engineering certification of the completed installation
be made.

TO HAVE AND TO HOLD said easements and rights of way unto the party of the second part its successors and assigns forever.
