WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$571,255.48 which includes an amount to be raised by taxation of \$570,119.00 and Total Appropriations of \$571,255.48; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 25, 2025 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2026 and ending December 31, 2026 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The tax levy presented in this budget is \$570,119 which is an increase of \$3,887 over the prior year. In addition, the 2026 tax rate will be 20.9 cents which represents no change from 2025.

Fund Balance Utilized decreased 100% due to the sale of a truck for \$100,000. SCBA Cylinders is a new \$10,000 line item that was added to help gradually replace the current cylinders that are due to be ineffective this year and in the future. The Supplemental Fire Service Grant Appropriation line item decreased \$1,136.48, and was accounted for in other line items as needed.

The Unrestricted Fund Balance is projected to increase by more than 10% in 2026 due to the District selling one of their Trucks for \$100,000. In addition, the restricted projected Fund Balance is subject to increase by more than 10 % due to the district increasing their Reserve for Future Capital Outlay by \$114,747.47 in 2025.

The District is Tax Levy Cap compliant.
