Membership Application

I understand that I am paying an initiation fee of \$ _____. I further understand that I may resign from Shalimar Pointe Tennis Club (hereinafter referred to as the Club), following my first 12-month commitment, by giving 30 days written notice. Should I choose to resign prior to my first anniversary date, I agree to pay the monthly dues for the 12-month period up to my first anniversary date (Active Duty military transfer per official orders is the only exception to this requirement). I understand that my resignation will not relieve me of outstanding initiation fee payments, purchases, or charges owed to the Club. I understand that my initiation fee is non-refundable and non-transferable and does not grant me any proprietary rights or ownership to the Club, nor does my acceptance as a member and payment of the initiation fee guarantee future membership rights to the Club.

I understand that all applications are subject to a routine credit check with the local credit bureau and final approval by the Club. If the Club disapproves this application, only my initiation fee will be refunded.

If my membership is terminated for delinquency, and if collection of my account requires the assistance of attorneys or a collection agency, I/We agree to pay the additional amount due on the account, reasonable attorney and court costs, as well as any initiation fees or dues owed.

I hereby acknowledge that the use of the Club facilities and privileges or service incident to membership is undertaken with knowledge of risk of possible injury. I hereby accept any and all risk of injury to myself, my guests, and family sustained while using the Club facilities or involved in any event or activity incident to membership in the Club. In accepting risk of injury, I understand that I am relieving the Club and their successors and assigns, their respective directors, officers, partners, shareholders, employees, agents, and affiliates from all loss, claims, injury, damages, or liability sustained or incurred by me, my guest, and my family resulting or arising from activities or events connected with membership in the Club and use of the Club facilities.

I hereby acknowledge receipt of the Shalimar Pointe Tennis Club Rules and Regulations and that I have read and understand them and agree to abide by and be bound by these terms, and the Club may amend conditions thereof as the same from time to time. I further acknowledge that I am not relying on any oral representations in acquiring a membership in the Club.

Rules and Regulations

SECTION 1.

Management of the Tennis Courts-

Set forth below is the Tennis rules and regulations for the Club. The Director of Tennis shall control all matters relating to the use of the tennis courts.

SECTION 2.

Hours of Operation-

The tennis courts shall be open as posted by the Director of Tennis and are subject to change.

1. Morning play may not begin until maintenance work is complete and the staff announces play may start.
2. The staff may close courts for maintenance.
3. Play may be restricted due to wet or frozen conditions.
 - a. Wet – courts must be firm with not standing water before play.
 - b. Frozen – courts must be thawed and firm with no standing water before play.
4. Reservations may be made after 8:00 AM the day before desired court time.
5. Play will be limited to 1½ hours if people are waiting to play.
6. League play and Club events take priority over individual matches for court times.

SECTION 3.

Registration-

1. All members and guests must register at the clubhouse before play.
2. The member or guest must pay the guest fee.

SECTION 4.

Dress Code-

1. Players must be dressed in proper tennis attire.
2. No play permitted without shirts.
3. Shoes shall be regular tennis shoes. No play in bare feet allowed.

SECTION 5.

Conduct-

1. Loud or boisterous conduct in the tennis area will not be permitted, and good sportsmanship on and off the courts is required at all times.
2. No radios are allowed on the courts.
3. Trash must be place in receptacles.
4. Smoking is NOT permitted on or near the courts, in the clubhouse or on the clubhouse deck.
