John Greenan

John Greenan serves as Executive Director of the Central Dallas Community Development Corporation, a non-profit organization founded in 2001 to act as the development and housing arm of CitySquare, a Dallas based, anti-poverty nonprofit organization. Since that time, the Central Dallas CDC has developed or constructed almost 1,000 residential units, 200,000 square feet of commercial space and developed close to \$200 million worth of assets.

Central Dallas CDC addresses homelessness with the model "Housing First," which provides immediate permanent housing solutions for the chronically homeless. Through their partnership with CitySquare, Central Dallas CDC ensures that residents stay safe, supported and productive by addressing immediate needs, providing ongoing case management, coordinating events and activities, and by strengthening the community through advocacy and empowerment. Most recently John oversaw the development of 50 tiny houses providing permanent homes for some of Dallas' most vulnerable homeless citizens.

John earned his Juris Doctorate from The University of Minnesota in 1984.

ABOUT US

DAGS is a non-profit, voluntary organization of gerontological professionals. Our purpose is to provide continuing educational programs, academic scholarships, and advocacy for senior issues.

CONTINUING EDUCATION PROGRAMS

DAGS meets on the 3rd Thursday of each month at 3:00 PM, offering the community an opportunity to visit different venues such as senior housing facilities and non-profit organizations. Speakers present a myriad of subjects related to aging. DAGS is comprised of professionals and community members interesting in aging. Continuing education units for professionals are available. ACADEMIC SCHOLARSHIPS

By 2020, one in six Americans is projected to be age 65 and older. Ten thousand baby boomers will turn 65 every day until the year 2030 (Census Bureau stats). The numbers suggest there are many opportunities in the rapidly growing fields of gerontology and related careers. DAGS will play a part in helping attract people to these careers through offering

scholarships to students specializing in studies related to aging. In its first year in 1989, DAGS awarded one modest scholarship. This year, DAGS awarded scholarships totaling over \$15,000, including sponsoring one through Dallas County Community College. The DAGS Scholarship committee reviews the submitted applications, performs in person interviews and selects those who show dedication to serving the aged population.

ADVOCACY FOR SENIOR ISSUES

With the growth of the senior population, public policy and advocacy for senior issues becomes ever more important. For over 25 years DAGS has strived to bring public awareness about issues impacting the senior population. A public policy issue (local, state, or federal) is discussed at each general meeting and members may be asked to contact their elected representatives, sign petitions and generally be both aware and actively advocate on behalf of seniors. Healthcare, affordable housing, transportation, senior recreation centers, protection from abuse and neglect, and support for the Older Americans Act are a few of the areas of interest and concern for DAGS.

Emergency Repair Program (ERP)

Provides up to \$7,500 in emergency assistance to qualified lowincome disabled and elderly homeowners that have been determined to need immediate action to protect the health or safety of the occupants and pose a threat to the life, health, or safety of the resident(s)

Eligible Repairs

- Sewer lines
- Gas lines
- Water lines and/ or water damage
- Roof
- Electrical systems
- Air conditioning & heaters (seasonal)
- ADA renovations-ramps, toilets, grab bars and other vital accessibility needs

ERP Eligibility Criteria

Client Eligibility

- Residential property must be located in the Dallas City limits
- Picture ID and Social Security card
- Seniors (62 and older) and or disabled
- Income 80% or less of median area family income for Dallas, based on number of persons in household, as defined by the Department of Housing and Urban Development annually
- The annual budget is \$1,050,604
- The projected annual production rate is 135 repair projects

Major Systems Repair Program (MSRP)

- Provides up to \$20,000 for repair or replacement of major systems from the following: electrical, plumbing, HVAC and roof, performed by certified contractors
 - > The annual budget is \$2,718,598.30
 - > The projected annual production rate is 135 repair projects

Major Systems Repair Program Eligibility Criteria

- Property must be located in the Dallas City limits
- Proof of ownership and occupancy for a minimum of two (2) consecutive years
- Proof of citizenship
- Proof of household size
- Proof of income at or below 80% AMFI (\$40,150 annually)
- Proof of insurance
- No liens allowed other than current mortgage

People Helping People Program

- Provides up to \$5,000 as a grant in materials and supplies for minor exterior repairs performed by volunteers, specialty repairs utilizing volunteer services and contractor services, and advocacy/referral services provided by staff
- Volunteer services include:
 - Repairing and painting the exterior of homes
 - Replacing broken window panes
 - Servicing working furnaces and heaters
 - Providing pest extermination services
 - Repairing porches and steps
 - Installing ramps and handrails
 - Demolishing dilapidated accessory structures
 - > Removing trash and debris

People Helping People Program

- Professional contractor provides repairs too extensive for volunteers or outside of expertise of volunteers as necessary for a complete job
 - Minor roof repairs
 - > Extensive exterior wood replacements
 - Handicap ramps
- Casework Advocacy and Referrals (EXAMPLES)
 - To other no cost repair services
 - Plumbing
 - Ramps
 - Social services referrals
 - Federal benefits
 - Meals on Wheels
 - Dallas Area on Aging
 - Advocacy Services
 - Elderly abuse

People Helping People Program Eligibility Criteria

➤ Homeowner Eligibility:

- Property must be located in the Dallas City limits
- Proof of ownership and occupancy for a minimum of two (2) consecutive years
- Proof of identity
- Must be 62 years or older or disabled
- Proof of household size
- Proof of income at or below 80% AMFI (\$40,150 annually)
- Scope of work must be appropriate for volunteer service
- Current on all property taxes
- Tax Deferred for 65 years and older or Disabled
- Annual Budget FY 16-17 \$1,019,051 from CDBG

Reconstruction Program (RECON)

- Provides up to \$103,000 zero-interest, deferred payment loan for demolition costs and on-site reconstruction of structures beyond economic feasibility for repair
 - > FY 15-16 last year for program
 - Funding Source: HUD CDBG Funds
 - > The annual budget for FY2015-2016 was \$1,221,964.00

Approved Program Revisions

- Given the increases in construction costs (materials and labor), recommendation was approved to increase Major System Repair Program (MSRP) maximum from \$17,500 to \$20,000
- The Home Rebate Program will provide rebates to property owners for eligible repairs. The Home Improvement Rebate Program will reimburse homeowners 25% of improvement cost up to \$5,000

- Designed to provide incentives for owners to invest in home improvements
 - Positively effect values in neighborhoods
 - Promote neighborhood assets
 - Encourage revitalization in Dallas neighborhoods
 - Maintain and stabilize existing housing
 - Improvement of conditions of housing in neighborhoods

- Program will provide financial assistance for the following residential and ownership types:
- Single family homes
- Duplexes

- Eligibility Criteria
 - Within Dallas City limits
 - Built in 1985 or earlier
 - Appraised at \$200K or less
 - Repairs requested are eligible for rebate after completion of work
 - Must be current on taxes and insurance
 - Improvements must total 10% or more of DCAD value of the property
 - 25% rebate on total repair costs up to \$5,000

- Eligibility Criteria
 - Start within 6 month of application
 - Completion of project within 6 month after start
 - Limited to one rebate per five year period
 - No partial rebates
 - Owner must agree to periodic inspection of repair work
 - Expenses include interior and exterior repairs and upgrades

- Non Eligibility Repairs
 - No Pools, Hot Tubs, SPA's and water features
 - No replacement of sprinkler systems lacking digital controllers with functional rain and temperature sensors
 - No detached accessory structures, garage enclosures, carports and condominiums.

Approved Revisions

April 8, 2015 - City Council approved the revision to the MSRP policy program statement to increase the maximum repair costs up to \$20,000
