

# A simple solution to VA's many problems

More than 18 months after Americans were shocked and appalled by revelations of veterans dying while waiting to receive much-needed medical care from the Department of Veterans Affairs (VA), the VA's problems are still far from fixed.

A steady stream of independent audits, media reports and congressional investigations prove this is the case. At the epicenter of the VA scandal in Phoenix, an Oct. 15 government report details how seven more veterans died after delays and lapses in care at the Phoenix VA Health Care System. "Veterans still facing major medical delays at VA hospitals," reads an Oct. 20 CNN headline. And after receiving information from the House Committee on Veterans' Affairs, the VA Office of Inspector General recently made criminal referrals for two senior executives it says gamed the VA's hiring system, enabling them to benefit from a total of more than \$400,000 in taxpayer-funded relocation expenses.

American veterans and taxpayers are rightly asking themselves, "When will the madness at the VA end?" Former Acting VA Inspector General Richard Griffin offered a blunt answer to that very question last year when speaking about the intentional manipulation of patient wait times by VA bureaucrats. "Once someone loses his job or gets criminally charged for doing this, it will no longer be a game. And that will be the shot heard around the system," he said.

Apparently, VA leaders weren't listening to Griffin. In the wake of the biggest scandal in VA history, which centered on patient wait-time manipulation, the department has successfully fired just three low-level employees for manipulating wait times. Not a single VA senior executive has been successfully fired for doing the same. It's a statistic that's almost impossible to believe, considering the fact that 110 VA medical facilities maintained secret lists to hide long waits for care.

Until the VA rids itself of those who engage in scandalous behavior, the department will always be mired in scandal. But unfortunately, indefensible civil service rules that put the job security of failing VA bureaucrats ahead of the safety of the veterans they are charged with serving are prolonging the agency's problems indefinitely. The VA's highest-ranking benefits executive, Danny Pummill, perfectly described the issue during a Nov. 2 congressional hearing. VA is often stuck with problem employees because "the rules, the regulations, the protections are such that it's almost impossible to do anything" to discipline most federal workers, Pummill said.

Pummill's moment of candor was a drastic departure from the VA's top leadership, who along with President Obama are actively opposing common-sense legislation the House of Representatives passed in July to tackle the VA's accountability crisis head-on. The VA Accountability Act would simply give the VA secretary the authority to fire or demote any employee for poor performance or misconduct while protecting whistleblowers and limiting the amount of time employees can spend on paid administrative leave.

VA leaders — the same ones who have only fired three people for wait-time manipulation — have put forth a number of laughable arguments against this effort to increase accountability at VA. Among them is the canard that making it easier to fire failing VA employees will somehow make it harder for the agency to attract top talent. They have it backwards. Perhaps what's really making it hard to attract top talent to VA is its notorious aversion to accountability.

As of mid-July, the department was struggling to fill nearly 41,000 open positions for doctors, nurses and other healthcare professionals. Faced with the grim prospect of working side by side with cold-hearted bureaucrats who chose to put veterans on secret waiting lists rather than providing them with the care they had earned, why wouldn't medical professionals and administrators simply choose to work elsewhere?

A White House veto threat regarding the VA Accountability Act is even more ludicrous in its approach. It suggests that granting the VA the ability to quickly fire corrupt or incompetent employees is somehow unconstitutional. Let's be honest. If you perform poorly in your job, you should be fired. To suggest that this basic tenet of common sense is somehow unconstitutional is completely absurd. The White House should be ashamed of itself for using such ridiculous logic in order to protect corrupt bureaucrats at the expense of veterans.

In order to field a winning team, the VA has to be prepared to cut its worst players. But time and again VA leaders and Obama seem unable and unwilling to do that. As a result, the department — forced to tolerate corruption, malfeasance and incompetence within its ranks — remains under the shadow of perpetual scandal.

The millions of American veterans who depend on the VA and the hundreds of thousands of VA employees who are dedicated professionals deserve better than this broken status quo. But until VA leaders and Obama make a commitment to supporting real accountability at the department, efforts to reform the VA are doomed to fail.

# Senate approves VA funding for fiscal 2016

Senate lawmakers advanced plans for a \$166 billion Veterans Affairs Department budget for fiscal 2016, a potential next step not only for veterans program funding but also a broader budget deal for all federal spending.

The military construction and VA spending measure is the first fiscal 2016 appropriations bill to make it through both chambers of Congress, although revisions from the \$163 billion House plan mean it will have to go through further negotiations before it can head to the White House for President Obama's final signature.

How soon that might happen is unclear. While the Senate passed the measure by an overwhelming 93-0 vote, leaders in that chamber said they see the legislation as a potential vehicle for a larger omnibus budget deal, one that is still being negotiated in advance of the Dec. 11 deadline facing lawmakers.

In late October, White House and congressional leaders announced the framework for a two-year budget deal that lifted spending caps both for defense and nondefense spending.

The move appeared to calm Democrats who had signaled an intent to stall the fiscal 2016 appropriations process over funding fights, but the specifics of each agency's appropriations still must be finalized by Congress. The two parties are still sparring over possible riders that might be attached to those measures, on such issues as immigration and abortion.

Senate passage of the VA budget bill gives lawmakers some momentum toward a budget compromise, and could give VA leaders an unexpected funding boost for the fiscal year.

VA leaders repeatedly have lamented earlier congressional plans to trim about \$900 million from the president's budget request for the department. On Tuesday, before the Senate vote, Republican leaders added about \$2 billion to the budget total, to cover unmet medication and benefits requests made by department leaders.

That move prompted Democrats to drop their concerns about the earlier funding levels, and would give a boost of 4 percent to department spending over fiscal 2015.

VA has seen its total budget nearly triple since the late 1990s, but department officials have insisted that increased demand on services still leave potential shortfalls in health care and facility construction funds.

The Senate plan would give VA about \$71 billion in discretionary spending for its fiscal 2016 programs and almost \$60 billion more in advance appropriations for fiscal 2017.

Sen. Mark Kirk, R-Ill., chairman of the Senate Appropriations Subcommittee on Veterans Affairs, praised Tuesday's vote as a step towards helping all veterans

"With \$1.1 billion in funding for veterans' care above the president's request and special protections for whistleblowers like doctors and nurses who speak up to protect our vets, I am proud we found a bipartisan path forward," he said in a statement.

# Ending Veteran Homelessness in NJ

## VA Has Housed 1,282 Homeless Veterans in NJ

Today is Veterans Day. It is a celebration to honor America's veterans for their patriotism, love of country, and willingness to serve and sacrifice for the common good. And what better way to honor them is to work to end homelessness among veterans.

The U.S. Department of [Veterans Affairs \(VA\) New Jersey Health Care System](#) is making great strides in housing homeless vets.

[NJ Counts 2015](#), the statewide point in time count of the homeless, found 738 homeless veterans that made up 695 households. Of these homeless veterans:

- 90% are single men,
- 60% have mental health issues,
- 55% have substance use disorders,
- 44% have medical problems,
- 75% of the homeless veteran population are over the age of 45 but the population is getting younger, and
- 20% have served in Iran/Afghanistan.

The VA in NJ has housed 1,282 homeless veterans (in fiscal year 2015.) The rate of housed veterans has doubled over the last two years. And of those veterans housed, 87% remain stably housed after 12 months.

The VA has shifted the way that it serves homeless veterans with a focus on street outreach, prevention and housing homeless veterans through the Housing First model, and providing permanent housing. It is reaching homeless veterans that traditionally were not accessing VA services.


New Jersey puts federal funding to end homelessness to good use. NJ receives:

- \$10 million annually in federal funding for a strong Supportive Services for Veteran Families (SSVF) program, and
- since 2009, New Jersey has received 935 HUD-Veterans Affairs Supportive Housing (HUD-VASH) vouchers.

The VA's Lyons campus will receive 50 additional vouchers in 2016. The [NJ Dept. of Community Affairs](#) (DCA) has provided 200 Housing Choice Vouchers for homeless veterans.

# House Panel Wants Answers on VA's Use of Paid Administrative Leave, Union 'Hit List'

The House Veterans' Affairs Committee is pressing the Veterans Affairs Department on the status of employees on paid administrative leave -- and what the department plans to do with a [union report](#) alleging egregious behavior by several supervisors.

“Please provide a by-name list of every VA employee currently on administrative leave longer than 14 consecutive days, to include duty location, job title, grade level, the reason the employee is on administrative leave and the date the leave started,” said an [Oct. 26 letter](#) from Chairman Jeff Miller, R-Fla., to VA Secretary Bob McDonald. Miller also asked the secretary for the total amount of money the department has spent on administrative leave for each of the last three fiscal years. According to the letter, the committee has been asking for that information since July 28, 2014. That’s around the time McDonald was confirmed as secretary.

The four-page letter specifically asked about the status of [Brad Curry and Lance Robinson](#), employees of the Phoenix VA Health Care System. The committee said they have been on paid leave since May 1, 2014. The panel also wanted to know about Philadelphia VA regional office employees Lucy Filipov and Gary Hodge, who have been on paid leave since June 2015. Curry and Robinson were top officials working at the facility at the center of the wait time manipulation scandal. Filipov and Hodge got into [hot water for ethics violations](#), not misconduct related to serving vets.

Miller also wants information related to Frederick Kevin Harris, a nursing assistant at the Alexandria, La., VA Health Care System, who was [charged with manslaughter](#) in December 2013 in the death of a patient. “Please provide an update regarding Harris’ employment status with VA,” said the letter. “If he remains an employee, please outline what his job duties and responsibilities are.”

The committee said the department has not yet responded to its requests for information in the Oct. 26 letter.

“We will respond to the chairman once appropriate actions are complete on the individuals listed in his letter,” wrote James Hutton, VA director of media relations, in an email responding to questions from *Government Executive*. “It is important that our response is thorough, as it applies to specific actions administered by the department, and respects the rights of the employees listed in the letter in order for any administrative actions to be upheld.”

Another issue in limbo is what Secretary McDonald plans to do with a July report compiled by American Federation of Government Employees Local 17, allegedly at McDonald’s request. The 40-page report details alleged incidents of harassment, discrimination, bullying and incompetence by “disruptive and ineffective” managers who work in VA’s Central Office. Miller again asked in the Oct. 26 letter for the status of the department’s “investigation started and when you expect it to be

complete.” The committee first ask for an unredacted copy of the report in July. *Government Executive* received a [redacted copy of the report](#) through a Freedom of Information Act request.

Hutton did not respond directly to questions about the status of the union report. “VA’s goal continues to be strengthening its culture of accountability and putting renewed focus on employee-led, veteran-centric change,” Hutton said. “Improvements in workforce culture, with a focus on ICARE values, will allow VA to address issues as they arise, rather than necessitating employee termination following repeated and/or pervasive poor behavior.”

Last week, the Senior Executives Association and Federal Managers Association sent McDonald a [letter](#) citing a “growing concern on the status of labor-management relations at the VA,” and asking that he give “little credence [sic]” to the report. SEA and FMA have called the union’s report a ‘hit list.’

“We ask that you examine the personnel records of those managers and supervisors listed in the report before any actions are taken,” the groups wrote. “We call upon you to examine charges filed against them and the failure to find supportive evidence.”

SEA and FMA said they had been contacted by several managers named in the report. “While they corroborated the fact that complaints have been filed against them, complaints were often found to be unsubstantiated. Because these managers and supervisors had repeated, yet groundless, accusations against them, FMA and SEA worry that instead of thoughtfully examining constructive means to improve VA, Local 17 is personally targeting managers and supervisors and perpetuating labor-management hostility,” the letter stated.

The groups also said that since the report surfaced, they have heard from “several VA managers and supervisors who have been verbally threatened and harassed by union representatives and members.”

Some of the allegations against the managers detailed in the report are specific examples of abuse or intolerance, while others are more general criticisms of managers’ leadership abilities and communication skills.

## **Theft From Educational Center**

[HOLMDEL](#) – An 18-year-old Ocean Township man was charged with theft after he allegedly stole the donations box from the New Jersey Vietnam Veterans Memorial.

On or about Nov. 20, the cash donations box at the New Jersey Vietnam Veterans Memorial, Vietnam Era Museum and Educational Center was stolen, police said.

According to court documents, between \$1,200 and \$1,500 was enclosed in the donations box, which was located in the lobby of the Vietnam Era Museum and Educational Center, when it was stolen.

Bujon Russell, 18, of Ocean Township, was later charged with third-degree theft in connection to the stolen donations box, police said.

His bail was set at \$7,500.

Subject: Requesting Guidance and Assistance - Blue Water Navy Veterans

Hello,

The Blue Water Navy Vietnam Veterans Association has, for the past several years, been working with the National Archives (College Park, MD) in their project to get Deck Logs scanned and placed on their public access portal. They currently are focusing on finishing up the Carrier Deck Logs, and will soon be moving to the AE/AOE hull types.

As you undoubtedly know, the VA is preparing new rules for adjudicating Blue Water Navy claims for herbicide exposure because of the Gray Ruling by the CAVC. Although I don't believe they have a deadline that can be enforced by anyone, they will eventually have to get those new regs submitted. Our current belief is that exposure will be granted for ports and harbors, and they may also grant exposure to the ships with presence in the Territorial Seas. Since that is the same results as the language of HR-969 and S-681, the cost of that legislation will be significantly impacted. However, we will not know what their new guidelines will be until they are presented. We may still need documentation such as Deck Logs and Command Histories. If so, we would like to stay one step ahead.

If the VA still requires proof of a ship's location, as they have been doing with Deck Logs for the ships that have been added to the Inland Water Service Project (Project 211 -

<http://www.publichealth.va.gov/exposures/agentorange/shiplist/list.asp> ), it will be much faster and easier to use the Command Histories of (at least) the Gun Line ships to identify which of those ships went into ports and harbors during the Vietnam War.

I understand that the Naval History and Heritage Command is the repository for those documents. I would like to find a way that we could work with you to get access to those documents. Would it be possible to begin another scanning project to make those documents publicly accessible via the Internet? Is that something you would allow outside volunteers to help with? Is there another method you might know of to make that documentation available to us so that it only needs to be handled once as opposed to responding to the thousands of requests you may soon be receiving for copies of the Vietnam Era ship documentation?

If you could assist by forwarding this email to someone(s) who could help us determine how this access can be made available, I would be very grateful.


