Hot Springs Village hosts Missoula Children's Theater Week-long Theatre Workshop, June 24-29, 2019

Dear Parents and Guardians,

The Hot Springs Village Concerts Association is bringing the Missoula Children's Theatre (MCT), the nation's largest touring children's theatre, back to Hot Springs Village for a week-long theatre workshop. The MCT tour directors will arrive in HSV on June 23, 2019 with a set, lights, costumes, props, and make-up...everything needed to put on a play – *except the cast*. The directors will hold an **open audition on Monday, June 24th at Woodlands Auditorium at 10:00 a.m.** and will cast 50-60 local students ages 7-17 to perform in the production of Gulliver's Travels. Although there is no guarantee that everyone who auditions will be cast in the play, **students wishing to participate in the workshop free of charge and to audition must arrive by 10:00 and stay for the entire two-hour session. The first rehearsal begins approximately 15-minutes after the audition.** This is a group audition—**no advance preparation is necessary**, but a smile ☺ never hurts. Students should be ready to have a good time!

Rehearsals will be conducted every day, June 24-28 from 10:00 a.m. to 2:15 p.m. at the Woodlands Auditorium, 1101 DeSoto Blvd. in Hot Springs Village. Although not all cast members will be needed at every session, those auditioning must have a clear schedule for the entire week and if selected, be able to attend all rehearsals required for their role and be available for all scheduled performances. A detailed rehearsal schedule will be distributed at the conclusion of the audition. Cast members scheduled for the full 4 hours and 15 minutes will be asked to bring a sack lunch to be eaten during the 15-minute break between sessions.

The show will be performed **Friday, June 28 at 5:30 p.m.** and again on **Saturday, June 29 at 3:00 p.m. at the Woodlands Auditorium.** A cast party will follow the Saturday performance.

This week-long theatre workshop is made possible free of charge by the Hot Springs Village Concerts Association with help from the Hot Springs Village Property Owners' Association Recreation Department. These organizations are pleased to provide this opportunity for our youth in support of the MCT's mission to develop life skills in children through participation in the performing arts.

	<p>Acting – Tuesday, June 25, 2:30-3:15: <i>The basic tools of an actor's trade - observation, memorization, concentration, and imagination are presented and explored in an entertaining manner. The students participate in a variety of fun exercises, learning to apply the actor's tools to both performing and everyday life.</i></p>
	<p>Mime – Wednesday, June 26, 2:30-3:15: <i>People communicate with each other in many ways. Much of that communication is done without ever needing to speak. See how isolations, illusions, key gestures, and body language are all used to tell a story.</i></p>
	<p>Stage Makeup – Thursday, June 27, 2:30-3:15 :<i>Makeup is the foundation and the most basic visual image for all performers. This workshop teaches students of all ages by demonstrating (on a few participants) corrective, character and special effects makeup for the theatre. Please note, this workshop is specific to theatre makeup techniques and is not a "face painting" experience.</i></p>
