MEMORANDUM FOR RECORD

SUBJECT: 2024 Psychological Operations (PO) Regimental Honors / MG Robert A. McClure Awards Panel Results

1. On 4 October 2024, The Psychological Operations Proponent's Office hosted the annual MG Robert A. McClure Medallion Awards Panel. The panel consisted of 13 representatives from across the Regiment, including PO Group Commanders and Command Sergeants Major, senior, mid, and junior leaders from across the force representing both the Active and Reserve components, as well as the Regimental Honorary Leadership.
2. The panel reviewed and voted on 122 MG Robert A. McClure medallion nominations (10x Gold, 27x Silver, and 85x Bronze nominations). This was the second largest number of nominations received in a single year in the program's history, Panel members approved or disapproved, recommended upgrade or downgrade, and scored each nomination utilizing a one to five scale with the ability to add an additional plus (+.25) or minus (-.25) to their score. A nominations total score developed the overall order of merit list for each medallion level.
